COMMISSIONER'S PROCEEDINGS
SPECIAL MEETING

The Board of County Commissioners held a Public Hearing June 17, 1980, at 1:30 P.M. in the Saratoga High School Lunchroom to consider vacating a road described as follows, to-wit:

"That portion of the SE $\frac{1}{4}$ NW $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, NEPSW $\frac{1}{4}$ and the W $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 16, the W $\frac{1}{2}$ NE $\frac{1}{4}$, E $\frac{1}{2}$ NW $\frac{1}{4}$, and the SW $\frac{1}{4}$ of Section 21, the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 28, the E $\frac{1}{2}$ NE $\frac{1}{4}$ and the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 29, all of Township 16 North, Range 83 West of the 6th P.M., Wyoming, being the description of a parcel of land of a total width of 80 feet, being 40 feet on either side of, and equidistant from a centerline described as follows:

Beginning at a point on the southerly right of way boundary of presently existing Wyoming Highway 130 which is 170 feet, more or less, easterly along the said southerly right of way boundary from a point on the north-south centerline of said Section 16 from which the center quarter corner thereof bears southerly a distance of 520 feet, more or less.

Thence S. 26°10'E., paralleling the west right of way line of the Saratoga and Encampment Railroad 2690 feet, more or less, to a point of a 15° curve to the right the radius of which is 382 feet; thence along said curve through an angle of 52°40', 351.1 feet. Leave railroad. Thence S. 26°30'W., 6009.8 feet to a point of a 3° curve to the right, the radius of which is 1909.9 feet; thence along said curve through an angle of 8°25', 313.9 feet; thence S. 35°55' W., 998 feet to point of a 5° curve to the left the radius of which is 1145.9 feet; thence along said curve through an angle of 15°300 feet; thence S. 20°55' W., 2810 feet more or less, to a point on the easterly right of way boundary of presently existing Wyoming Highway 230.

Said parcel of land containing 24.7 acres, more or less.

The Board of Commissioners along with Lance Stewart, Planning and Zoning Administrator and County Attorney K. Craig Williams met on the site to determine the condition of the existing County Road #630 and exact description of the right of way boundary.

Objections to the abandonment were made by Gerald Russell, attorney for Mr. & Mrs. Winthrop Condict in regards to the existing right of way and easement with the Game and Fish Department for public access.

John McPherson, attorney for Plattoga Ltd., stated there was a possibility of a negotiated abandonment years ago with Game and Fish and also submitted a question to the Commissioners whether the County wants to maintain the road as it now exists.

Mr. John Andrikopoulos presented a map showing that the Game and Fish Department have access along Treasure Island.

After all public comments were made, the meeting was adjourned. No action was taken.

CAMPAIGN REPORTING REQUIREMENTS, 22-25-106, W.S. 1977 - All Candidates whether successful or not must file a statement of campaign receipts and expenditures by September 16, 1980.

FILING OFFICES, 22-25-107, W.S. 1977 - Candidates for municipal, County, judicial, school or college board offices file with the County Clerk. Candidates for state legislative or district judgeship offices file with the County Clerk and Secretary of State. Candidates for statewide offices file with the Secretary of State.

A candidate who fails to file a full and complete itemized statement within the time required is guilty of a misdemeanor and no such candidate shall receive a certificate of nomination or election nor shall he enter upon the duties of the office, and a vacancy shall exist.
