A permit to conduct services over and along lands owned, leased by Carbon County, Permit #40, to Marathon Oil, located in T20N, R78W, Sec. 23, 26, 27, 34 and 35 and T19N, R78W, Sec. 2, Carbon County, Wyoming.

BOARD OF EQUALIZATION

On May 26 and 27 the Commissioners met to hear assessment protests. No protests were made.

JUSTICE OF THE PEACE

A motion was made by McMahon and seconded by Grieve to appoint David E. Erickson to fill the unexpired term of Wade Waldrip as Justice of the Peace in Rawlins. Roll was called with the following results: Grieve, Aye; McMahon, Aye; Lemich, Aye.

POSTAGE MACHINE

The Commissioners agreed to the purchase of a new postage machine for the County. The machine currently in use will be located in the Carbon Building for the use of County Offices located there.

MC DONALD'S CORPORATION

The Commissioners entertained a request to authorize \$1,000,000.00 worth of Industrial Revenue Bonds for McDonald's Corporation to locate in Rawlins. The Commissioners suggested the Company request the City of Rawlins to review the proposal.

FUEL CONSERVATION CONCEPTS, INC.

Lemich made a motion which was seconded by McMahon to install an energy saving device in the Rawlins Senior Center. Roll was called with the following results: Grieve, Aye; McMahon, Aye; Lemich, Aye.

COUNTY PROPERTY

Malcolm Smith discussed the status of a lease he holds from the County on a parcel of land located near the Pine Cliff Apartments on the West end of Rawlins. Craig Williams, County Attorney, will research the records and make a determination.

MICRONIX

Dr. Chittori of Micronix reported to the Commissioners on his findings at the Hospital when he reviewed their current data processing system. He also offered to submit a proposal to conduct a study for the County Data Processing System. The Commissioners indicated they felt no need for a study to be made at this time.

JUSTICE OF THE PEACE

The Commissioners authorized the attendance of the Justices of the Peace and their clerks at a Minor Courts Seminar at Casper College on June 12, 13 and 14, 1981.

MOUNTAIN VIEW CEMETERY

Bert Oldman, President of the Mountain View Cemetery Association in Encampment, requested the County repair the road to the Cemetery. He offered to supply the gravel if the County would do the work. The Commissioners indicated they would request Road & Bridge to look into the matter.

BANNER & ASSOCIATES

Allen Bonnett advised the Commissioners that a Rawlins office has now been established and they would appreciate any consideration for future County projects.

FIRE DEPARTMENT/SHERIFF DEPARTMENT

A motion was made by McMahon and seconded by Grieve to accept the Agreement between the County and Rochelle Lands for Lease/Option of a building located on Airport Road. Roll was called with the following results: McMahon, Aye; Grieve, Aye; Lemich, abstain.

There being no further business, the meeting was adjourned until the following day.

Wednesday, June 3, 1981

WATER COMMISSIONERS

Earl Michael, State Board of Control, met with the Commissioners to discuss plans for the 1981-82 fiscal year and to request a \$6,600.00 increase in their budget. The matter was taken under advisement.

AMERICAN OFFICE EQUIPMENT

George Budin, Sales Representative, presented literature and information on the copier equipment his Company has available. The Commissioners advised that the Department Heads are responsible for review and recommendation on equipment purchases in their departments.

MEMORIAL HOSPITAL

Board Members from the Hospital requested permission to proceed with preliminary testing on the soil and plans for an administrative wing for the Hospital. The Commissioners indicated they would like to see them proceed with preliminary plans.

PUBLIC HEALTH NURSE

A rental agreement between the County and Wilson Rentals covering the Public Health Nurse's office at 204 W. Bridge Street, Saratoga, for the 1981-82 fiscal year was approved.

MEDICINE BOW HEALTH CENTER

Bill Cooper and Irene Hobbs of Medicine Bow and two representatives from the College of Human Medicine, University of Wyoming, met with the Commissioners to discuss plans for a health center in Medicine Bow. Several grant possibilities and applications were discussed. The Commissioners agreed to set aside monies in the 1981-82 budget to build the building, pending procurement of funding for start-up and operating expenses. A grant for the land is being applied for from the Union Pacific Foundation.

PLANNING & DEVELOPMENT

The following cases were presented to the Commissioners:

Case 81-4 - Zone Change - Dudley and Judy Fennell, P.O. Box 1614, Saratoga, Wy. 82331 - Zone change from RAM (Ranching, Agriculture & Mining) to RD-40 (Residential Development) to allow for the construction of one single-family residence and outbuildings for the keeping of livestock on a 40-acre parcel northeast of Saratoga, Wy. Site is legally described as SE $\frac{1}{4}$, NW $\frac{1}{4}$, Section 33, Township 18 North, Range 83 West, Carbon County, Wyoming. A motion was made by McMahon and seconded by Grieve to approve the request. The motion was unanimously carried.

Case 81-13 - Zone Change - Cecil Campbell, 419 East Spruce, Rawlins, Wy. 82301 - Zone change from RAM (Ranching, Agriculture & Mining) to Industrial to allow for the development of a 50-acre parcel of land into an industrial subdivision. Site is legally described as the N $\frac{1}{2}$ of Section 24, Township 21 North, Range 87 West, Carbon County, Wyoming. A motion was made by Lemich, seconded by McMahon and unanimously

carried to table the request.

Case 81-10 - Amendment to the Subdivision REgulations of Carbon County, Wyoming - Specifically Section 4.04, Minimum Requirements for Subdivision Permits, to add a section to provide regulations with respect to any water rights appurtenant to lands to be subdivided. A Motion was made by Lemich, seconded by McMahon and unanimously carried to table the request.

Case 81-11 - Amendment to the Subdivision Regulations of Carbon County, Wyoming - Specifically Section 5.00, Subsection 5.08, to add a paragraph to provide for lot size with regards to water and sewer provisions in commercial or industrial subdivisions. A motion was made by Lemich, seconded by McMahon and unanimously carried not to approve the request.

Case 80-15 - Subdivision Re-Plat - Curtis Rochelle, P.O. Box 996, Rawlins, Wy. 82301 - For re-plat to provide for the addition of approximately thirty one-acre lots to the original Final Plat which was approved by the Board of County Commissioners on June 6, 1978. Site is legally described as NE $\frac{1}{4}$, Pt NW $\frac{1}{4}$, SW $\frac{1}{4}$ Section 25; Pt SE $\frac{1}{4}$ Section 24, Township 17N, Range 88W, Carbon County, Wyoming. A motion was made by McMahon, seconded by Grieve and roll was called with the following results. McMahon,Aye;Grieve,Aye;Lemich,Abstain.

UNION PACIFIC RAILROAD COMPANY RESOLUTION 1981-5

The following Resolution was approved by the Commissioners:

RESOLUTION 1981-5

WHEREAS, UNION PACIFIC RAILROAD COMPANY has tendered to the COUNTY OF CARBON, State of Wyoming, an agreement covering the right to use for public roadway purposes a portion of the right-of-way of the Railroad Company at Mile Post 21.44 Encampment Branch in Carbon County, Wyoming, said agreement being identified as Union Pacific Railroad Company C.D. No. 47641-2; and

WHEREAS, it is considered that the best interests of said County will be subserved by the acceptance of said agreement;

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CARBON:

That the terms of the agreement submitted by Union Pacific Railroad Company as aforesaid be and the same hereby are accepted in behalf of said County;

That the Chairman of the Board of County Commissioners of said County hereby is authorized, empowered, and directed to execute said agreement on behalf of said County, and that the County Clerk hereby is authorized and directed to attest said agreement and to attach to each duplicate original of said agreement a certified copy of this resolution.


