The Commissioners expressed their appreciation for Mr. Zeiger's services on the Board.

AIRPORT BOARD

The Airport Board presented a revised budget for the Commissioners' review. The revision requested \$33,250. rather than the initial request of \$75,750.

ROAD & BRIDGE

A Permit to construct access driveway, Permit #41, was granted to Amoco Pipeline Co., Denver, Colorado, for a pump station located on Carbon County Road #407, Section 24 and 25, Township 21N, Range 86W, Carbon County, Wyoming.

A Permit to construct a 4" PVC Water Main, Permit #42, was granted to Arch Mineral Corp., Hanna, Wyoming, located on Carbon County Road #291, Section 9, Township 22N, Range 81W, Carbon County, Wyoming.

LIBRARY BOARD

A motion was made by Lemich and seconded by McMahon to re-appoint Carol Palm to the Library Board to serve a three year term beginning July 6, 1981. The motion was unanimously carried.

The Committee would consist of representatives from all towns and would require a \$20,000.00 budget. The matter was taken under advisement.

Cissy Whitfield met with the Commissioners to increase the original Child Development Center budget request.

RATTLESNAKE PASS ROAD

Carolyn Duncan asked if Road #400, Rattlesnake Pass Road, is a County Road. The

PLANNING/DEVELOPMENT

Case 81-13 - Zone Change - Cecil Campbell, 419 East Spruce, Rawlins, Wyoming 82301 - zone change from RAM (Ranching, Agriculture & Mining) to industrial to allow for the development of a 50-acre parcel of land into an industrial subdivision. Site is legally described as the N $\frac{1}{2}$  of Section 24, Township 21 North, Range 87 West, Carbon County, Wyoming. A motion was made by Lemich, seconded by McMahon and unanimously carried to remove from the table Case 81-13. A motion was then made by Lemich and Seconded by McMahon to approve Case 81-13, contingent on the presentation of a legal description of the 50 acres. Roll was called with the following results: McMahon, Aye; Grieve, Aye; Lemich, Aye.

Case 81-10 - Amendment to the Subdivision Regulations of Carbon County, Wyoming - specifically Section 4.04, Minimum Requirements for Subdivision Permits, to add a section to provide regulations with respect to any water rights appurtenant to lands to be subdivided. A motion was made by Lemich, seconded by McMahon and unanimously carried to remove from the table Case 81-10. A motion was then made by McMahon and seconded by Lemich to approve case 81-10. Roll was called with the following results: McMahon, Aye; Lemich, Aye; Grieve, Aye.
