HANNA FIRE DEPARTMENT


A delegation from the Hanna Fire Department requested assistance in funding a County Ambulance & Fire House, to be included in the new Hanna building, now being built.

A motion was made by McMahon and seconded by Grieve to approve the bid of \$11,674.00 by Tolhurst Construction Inc. for construction of part of the building to help house the County equipment. The motion was unanimously carried.

FAIRBOARD-GRANDSTANDS

McMahon made a motion which was seconded by Grieve to accept the contract with Southern Bleachers Construction Co. for erection of the grandstands, contingent upon the inclusion of a liability clause, lien waiver clause and receipt of a Performance Bond. Roll was called with the following results: Grieve, Aye; McMahon, Aye.
