PUBLIC HEALTH NURSE

The Commissioners agreed to increase the Public Nursing Service to the Baggs area by 1/2 day per week. The Nurse will be serving the Baggs/Dixon/Savery area 2½ days per week. These costs are divided 50/50 with the Nursing Services of Wyoming. Kate Murphy presented the Commissioners with an overview of the services she currently offers to the citizens of this area.

ENCAMPMENT SENIOR SERVICES

A delegation from Encampment met with the Commissioners to inform them the City will donate 8, 115' x 25' lots for the building of a Senior Center. They discussed their anticipated needs as far as space was concerned. The Commissioners requested that the citizens obtain plans and estimated costs for the Center and return by the 1st of May.

MEMORIAL HOSPITAL/AMBULANCE SERVICE

Representatives from the outlying Ambulance Services and the Hospital representatives met with the Commissioners regarding a policy being established for EMTs and Ambulance Drivers. When finalized, the policy will be adopted by the County for the Ambulance Service and the Hospital.

PUBLIC HOUSING

Miles Lance, Architect from Denver, presented a plan to the Commissioners for Public Housing in Carbon County through a Housing Authority. The matter was taken under advisement.

SENIOR SERVICES

Evelyn Mincer reported on the progress of the Baggs and Hanna Centers. The Commissioners agreed to have a trash container built by Carl Foster at a cost of \$298.00. Several vouchers were presented and approved.

There was some discussion on the possibility of purchasing a building the School District has for sale for use as a Senior Center in Medicine Bow. This matter will be taken under advisement.

PLANNING & DEVELOPMENT

Case #80-21 - Zone Change - Henry W. Smith, P.O. Box 1173, Rawlins, Wy. 82301 - zone change from RAM (Ranching, Agriculture & Mining) to RD-10 (Residential Development) to allow for construction of a single family residence on a 10-acre parcel. Site is legally described as NE $\frac{1}{4}$, NE $\frac{1}{4}$, SW $\frac{1}{4}$, Section 13, Township 21 North, Range 88 West, Carbon County, Wyoming.

JACK CREEK DRAINAGE


COUNTY ATTORNEY
