CARBON COUNTY COUNCIL OF GOVERNMENTS

Margaret Brown, a C.O.G. member, and Kathi Gray were in attendance at the NARC Annual Conference in Louisville, Kentucky, and gave a report to the Commissioners on the highlights of the Conference which covered a wide range of problems confronting local governments. They commended Margaret for being elected delegate-at-large to the National Association of Regional Councils of Governments, Board of Directors.

June 1, 1982

CARBON COUNTY EMERGENCY SERVICE AGENCY

A motion was made by Lemich, seconded by McMahon and unanimously carried to terminate the contract of Ruth Bergstrand as coordinator for the Carbon County Emergency Services Agency. Mrs. Bergstrand will be re-instated as coordinator as a salaried County employee.

A motion was made by Lemich and seconded by McMahon to adopt the following resolution:

RESOLUTION 1982-5

A resolution providing for the organization (Wyoming Statutes, Chapter 5, Section 19-5-108, 1977 as amended) of an Emergency Management Department (referred to as Disaster and Civil Defense) and its governing council to:

- (1) Prepare and exercise operational plans for the preservation of life, protection of property and restoration of the economy.
- (2) Effect coordination of other public departments, industry and citizens with emergency responsibilities and functions.
- (3) Function as specified by the emergency plan during emergencies declared by such local governments.
- (4) Provide for a coordinator and the enrollment of assistants and defining their powers and duties.
- (5) Authorize acceptance of services, equipment and funds, etc. from the federal/state government and other public and private sources.

Emergency Management (referred to as Disaster and Civil Defense) shall mean planning for and carrying out of emergency functions including prevention, response and recovery from disaster events. This includes, but is not limited to, disorder, flood, fire, sabotage, blizzard, tornado and other natural, man-caused or nuclear emergencies.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING AND THE COUNCIL(S) OF THE INCORPORATED COMMUNITY(IES) OF Rawlins, Wyoming:

Section 1: That there is hereby created the Carbon County/City Emergency Management Department which shall be governed by a Council consisting of:

The County Commissioners
Council members and/or chief executive of signator incorporated communities
Sheriff (optional)

The Chairman of the County Commissioners shall be Chairman of the Council. The Vice Chairman shall be elected by the Emergency Management Council.

Section 2: That the primary responsibility for initiating action at the time of an emergency or disaster rests with the elected government of the county or incorporated community involved. A declaration of an emergency and subsequent assistance requests during or on account of an emergency or disaster in Carbon County or its communities will be honored only when the emergency is declared by the chief elected official and/or emergency council.

Section 3: That the Carbon County/City Emergency Management Council is empowered to prepare, review and recommend to the County and community governing bodies a local emergency operating plan and mutual aid agreements.

Section 4: That it shall be the duty of the Emergency Management Council to promulgate such rules and regulations necessary for the efficient management and operation of the Carbon County/City Emergency Management Department, including such reasonable regulations prescribed by the State Coordinator (W.S. 19-5-105(c)).

Section 5: That the Carbon County/City Emergency Management Council will support for day to day and emergency use the establishment of an Emergency Operating Center(s) - to include essential communications and operating equipment.

Section 6: That the Emergency Operating Center of Carbon County shall be located at Rawlins. That the Emergency Operating Center for Carbon County shall be located at Rawlins at the Sheriff's Office. Emergency situations may warrant the establishment of a point of operation at the scene of the disaster.

Section 7: That the succession of authority within the Emergency Management Council for Carbon County will be as depicted in Local Emergency Operations Plan (Direction and Control).

Section 8: That the Carbon County Emergency Management Council shall recommend to the Governor of Wyoming a person to serve as Coordinator for the Council who shall serve at the pleasure of the Council and the Governor.

Section 9: That the Carbon County Emergency Management Council will, with the consent of the Governor, designate agent(s) to receive services, equipment, funds, etc., offered by federal/state grant or loan and other donors.

Section 10: Coordinator - powers and duties:

The Coordinator is hereby empowered and directed:

- (a) To prepare a local Emergency Operating Plan for Carbon County and assist in the preparation of a (Local Emergency Operating Plan) for the incorporated communities where appropriate.
- (b) To assist in the coordination of emergency responsibilities and functions of local governments, industry and citizens of the counties and communities.

June 1, 1982

- (c) To establish a program of effort to prevent and reduce the potential effects of disasters.
- (d) To execute directives and policies established by the County/City Emergency Management Council.

Section 11: This resolution is hereby declared to be a measure necessary to provide coordination with Federal and State Emergency Management agencies and for the immediate preservation of the public peace, health and safety and shall take effect and be in force from and after passage.

Any portions of prior resolutions adopted by the Carbon County/City Emergency Management Council which are in conflict with the letter and intent of this resolution are hereby rescinded.

BUDGET SUPPLEMENT

A motion was made by Lemich, seconded by McMahon and unanimously carried to adopt the following Resolution:

RESOLUTION 1982-6

WHEREAS, the Budget Officer of Carbon County, Wyoming, Mary G. Bradford, has recommended to the Board of County Commissioners, that \$18,000 be transferred from the budget of the County Surveyor to the budget of the County Attorney, and \$12,000 be transferred from the Election budget to the Data Processing budget; and

WHEREAS, said proposed transfers have been duly published; and

WHEREAS, the said proposed transfers are for unencumbered and unexpended funds in the two budgets from which the transfers will be made;

NOW THEREFORE, in consideration of the premises, it is hereby RESOLVED AS FOLLOWS:

1. There is hereby transferred from the budget of the County Surveyor \$18,000. to the budget of the County Attorney.

2. There is hereby transferred the sum of \$12,000. from the Election budget to the Data Processing budget.

INTER-GOVERNMENTAL CONTRACT AGREEING TO PARTICIPATE IN
THE SARATOGA AREA WASTEWATER TREATMENT SYSTEM

THIS AGREEMENT, made and entered into the 2nd day of June, 1982, by and between the following-named parties:

WHEREAS, these three entities desire to enter into this Agreement to indicate their intent as to participation in a proposed regional wastewater treatment system; and,

WHEREAS, in doing so, the desire and intent of the parties is to clarify their individual duties, responsibilities, expectations, and rights to the fullest possible present extent; and,

WHEREAS, an express intention of the parties is to satisfy the EPA Region VIII, State of Wyoming Department of Environmental Quality, and any other State agency requirements, in order to obtain federal and state aid in the form of financial grants or otherwise.

WITNESSETH:
