PETITION FOR THE ESTABLISHMENT OF CARBON COUNTY ROAD

A petition was received for the establishment of a County Road beginning at a point of intersection of the westerly right of way line with U.S. Highway 287 more particularly described as follows:

Said point being South 44 degrees 22 minutes East, 5,175.02 feet more or less from the Northwest corner of Section 8, Township 23 North, Range 88 West, Thence North 72 degrees 39 minutes West 197 feet, Thence North 54 degrees 47 minutes west 21,636 feet more or less, Thence north 57 degrees 17 minutes west, 2,419 feet more or less, Thence north 69 degrees, 34 minutes West 235 feet more or less, Thence North 85 degrees 22 minutes west 164 feet, Thence South 82 degrees 21 minutes west, 4,203.85 feet more or less, Thence south 82 degrees 41 minutes West, 7,826 feet more or less, Thence along a curve to the right with an ARC length of 1,270.42 feet more or less and a radius of 2,864.79 feet. Thence North 72 degrees 47 minutes West, 2,821.58 feet more or less, Thence along a curve to the right with an ARC length of 2,179.42 feet more or less and a radius of 5,729.58 feet more or less, Thence North 50 degrees 59 minutes 21 seconds West, 849.84 feet more or less, Thence along a curve to the left with an ARC length of 1,551.44 feet more or less and a radius of 5,729.58 feet more or less, said point also being North 0 degrees 37 minutes 14 seconds West, 1,508.43 feet more or less of the Southwest corner of Section 30 of Township 24 North, Range 89 West, 6th P.M., and also being on the Carbon and Sweetwater County Line.

A motion was made by Lemich, seconded by McMahon and unanimously carried to appoint Arthur Greene a Viewer for said road.
