A motion was made by Lemich, seconded by McMahon and unanimously carried to write a letter to the Wyoming Department of Health and Social Services indicating a willingness for Carbon County to participate in the Community Services Black Grant Program.

CARBON COUNTY SHERIFF-FOREST SERVICE AGREEMENT

The following Agreement was signed by the Commissioners:

Operating and Financial Plan - Reimbursable Services Requested by Forest Service

This plan, made and agreed to this 1st day of October, 1982, for the period beginning October 1, 1982 and ending September 30, 1983, by and between the Service and Sheriff, Carbon County, Wyoming, becomes a part of the agreement between said parties dated June 20, 1981.

A. The Sheriff, Carbon County, Wyoming agrees:

1. The sheriff agrees to assign a vehicular patrol on the Medicine Bow National Forest in the area listed on the attached schedule. These patrols can be rescheduled or deleted as determined by the designated Forest Officer. The patrol schedule is subject to the availability of funds.
2. When requested by the service, the sheriff agrees to dispatch additional deputies within his manpower capabilities to unforeseen emergency situations.
3. Sheriff or personnel assigned duties in items 1 and 2 above will be regular employees of the Carbon County Sheriff's department.
4. To furnish the Service itemized statements quarterly on the forms provided by the Service, for the expenditures in Clauses A-1 through A-3 above. The statement should be sent to the Forest Supervisor, Medicine Bow National Forest, Laramie, Wyoming.
5. To furnish the Service a quarterly report of law enforcement activities relating to (1) Patrols made and miles traveled, (2) Manhours worked, (3) Arrests on federal lands, misdemeanors and felonies, (4) Incidents investigated or responded to including search and rescue, (5) Assistance given to Service personnel.
6. To impound abandoned property including vehicles, trailers and other wheeled vehicles for transportation of the property from the National Forest. This action will be at the request of the Service.

B. The Service agrees:

1. To loan to Sheriff, Carbon County, Wyoming, equipment as needed and when mutually agreed to. A list of such equipment will be attached to this plan as schedule B. While in the possession of the Sheriff, Carbon County, Wyoming, maintenance of this equipment will be the responsibility of the Sheriff, Carbon County, Wyoming and it will be returned in the same condition as taken.
2. To reimburse the Sheriff, Carbon County, Wyoming on receipt of satisfactory statements of expenditures in accordance with the following schedule, but not to exceed a total of \$4,000.00 for the period established for this plan. Reimbursement for costs associated with the removal of impounded property will be made by the Forest Service to the individual who removes the property on receipt of satisfactory statements of expenditure. Impounded expenditures shall be kept separate from other statements for patrol and unforeseen or emergency requests.

Rate Schedule for Reimbursable Services

For the services in items A, 1 & 2 above the Service agrees to reimburse the cooperator at the rate of \$7.50 an hour per deputy and 36¢ a mile for vehicle mileage. It is mutually understood that no reimbursement will be made for search and rescue activities conducted in conjunction with or part of this joint operating and financial plan. It is estimated that the total expenditure for services listed in items A, 1, 2 and 6 above will be approximately \$4,000.00 per year. This shall include approximately \$300.00 for item A6 described above.

C. It is mutually agreed that the following shall be the designated representative of each party:

The installation of the cable will facilitate the use of the County Computer system by the County Departments located in the Carbon Building.

VACATION OF CARBON COUNTY ROAD NO. 5

A motion was made by Lemich and seconded by McMahon to adopt the following Resolution:

RESOLUTION VACATING A PORTION OF COUNTY ROAD FIVE - 1982-12

WHEREAS, by various prior actions, the Courts of the State of Wyoming and the Board of County Commissioners of Carbon County, Wyoming, have partially vacated unused portions of County Road Five; and

WHEREAS, the portion of County Road Five to be vacated pursuant to this Resolution is utilized only by the land owners seeking vacation of the County Road and by one other private individual who will receive an easement to obtain access, and who has filed no objection to these proceedings, and the County Road serves no other useful or legitimate purpose; and

WHEREAS, the necessary legal steps have been accomplished for vacation of the portion of County Road Five to be vacated by these proceedings;


CARBON COUNTY COURTHOUSE
