HANNA CARBON COUNTY JOINT POWERS BOARD

Members of the Hanna-Carbon County Joint Powers Board met with the Commissioners to discuss the costs and the funding for the Hanna Recreation Center. The cost of the project is estimated at \$2,693,000.00. The funds available are as follows:

Farm Loan Board Loan for \$2,000,000.00 guaranteed by Rocky Mountain Energy and DRAUO.

Farm Loan Board Grant for \$500,000.00

Additional funds required \$192,000.00

A motion was made by McMahon and seconded by Lemich that the \$100,000.00 budgeted by the County for operational costs of the Center be authorized for construction costs. Roll was called with the following results: Grieve, aye; McMahon, aye; Lemich, aye.

CARBON COUNTY ROAD & BRIDGE

A motion was made by McMahon, seconded by Lemich and unanimously approved to accept the bid of Colman Equipment Company for a Reversible Snow Plow in the amount of \$4,503.00

MEDICINE BOW CLINIC

A motion was made by McMahon and seconded by Grieve to sign the contract with E. Duane Johnson, Rawlins, Wyoming, for the construction of a 2352 square foot medical clinic, utilizing a modular structure manufactured by Interstate Homes, Inc., including all labor and materials to complete the proposed structure in accordance with the plans and specifications. Signing of the contract will be contingent upon the approval of the contract by the County Attorney. The contract sum is \$124,000.00. Roll was called with the following results: McMahon, aye; Grieve, aye; Lemich, absent.

There being no further business, the meeting was adjourned.
