RYAN PARK SNOW MOBILE PARKING LOT

A motion was made by Lemich and seconded by Grieve and unanimously carried to execute a Memorandum of Understanding by and between the United States Forest Service and Carbon County, as follows:

## MEMORANDUM OF UNDERSTANDING

CARBON COUNTY COMMISSIONERS  
CARBON COUNTY, WYOMING

FOREST SERVICE  
U. S. DEPARTMENT OF AGRICULTURE

PARTIES TO AGREEMENT: This Memorandum of Understanding, made and entered into this the 16th day of November 1982, by and between the Forest Service, U. S. Department of Agriculture, hereinafter called "Forest Service," and the Carbon County Commissioners of Carbon County, Wyoming hereinafter called the "Commissioners."

Purpose of Agreement: The purpose of this agreement is to set forth the general terms and conditions, acceptable to the parties hereto, for the planning, survey, design and construction of an addition to the snowmobile parking lot located near Ryan Park, Medicine Bow National Forest.

Now Therefore, this Memorandum of Understanding witnesses that:

## 1. The Forest Service Agrees:

- a. To complete the planning, design and necessary plans for the addition of approximately 1.33 acres to the existing parking lot and provide the Commissioners with the necessary copies of the plan and specifications.
- b. To provide the necessary engineering services to construct the parking lot addition.
- c. To designate and dispose of merchantable timber located within the boundaries of the parking lot addition.
- d. To assume responsibility for maintenance and signing costs of the parking lot addition.
- e. To provide gravel and borrow material in the amounts and location shown in the plans and specifications.

## 2. The Commissioners Agree:

- a. To bear the cost of construction of the parking lot addition. The project will be accomplished by contract and the cost will be determined on the basis of the lowest acceptable bid.
- b. To assume the responsibility for settlement of any and all claims by the contractor occasioned by the construction of the parking lot addition.
- c. To protect and preserve soil and vegetative cover and scenic and esthetic values on lands located immediately outside of the construction limits.
- d. Control construction under its contracts to assure work is in accordance with the plans and specifications provided by the Forest Service.

## 3. The Commissioners and the Forest Service mutually agree:

- a. Nothing in the Memorandum of Understanding shall be construed as obligating the Forest Service or the Commissioners in the expenditure of funds or for the future payment of money in excess of appropriations authorized by law.
- b. That no Member of, or Delegate to Congress, or Resident Commissioner, shall be admitted to any share or part of this agreement, or to any benefit that may arise therefrom; but this provision shall not be construed to extend to this agreement if made for a corporation for its general benefit.
- c. To accomplish all cooperative work provided for by this Memorandum of Understanding or cooperative agreements without discrimination against any employee, or applicant for employment, because of race, creed, religion, sex, color or national origin.
- d. That this Memorandum of Understanding shall become effective when signed by the parties hereto and shall remain in force until terminated by mutual agreement, or by either party upon sixty (60) days' notice in writing to the other of its intention to terminate upon a date indicated. Amendments may be proposed by either party and shall become effective upon approval by both parties.

IN WITNESS WHEREOF, the parties hereto have executed this Memorandum of Understanding and recognize its effective date to be the last date written below.

RESOLUTION NO. 1982-13

RESOLUTION ESTABLISHING OPTIONAL ONE PERCENT  
SALES AND USE TAX IN CARBON COUNTY, WYOMING

WHEREAS, pursuant to Wyoming Statutes Section 39-6-412, 1977 and Section 39-6-518, Wyoming Statutes 1980, Carbon County, Wyoming is authorized to impose additional Sales and Use Tax for the County under the procedures set forth therein; and

WHEREAS, the prerequisites to adoption of this Resolution have been fulfilled including approval by the Electors of the County.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Carbon County, Wyoming as follows:

1. There is hereby adopted in Carbon County, Wyoming an Excise Tax upon every retail sale of tangible personal property, admissions and services made within the County at the rate of one percent in addition to the three percent tax imposed by the State.
2. There is hereby imposed an Excise Tax at the rate of one percent on the storage, use and consumption of tangible personal property in the County. This one percent shall be in addition to the three percent Use Tax imposed by the State of Wyoming.
3. For the purpose of the taxes created hereby, Carbon County hereby adopts the provisions of Article IV and Article V of Chapter 6 of Title 39 of the Wyoming Statutes, 1977 as they are amended from time to time insofar as they are relevant. Any amendments made to the said Articles not in conflict with Section 39-6-412 shall automatically become a part of this Sales Tax Resolution.
4. Carbon County shall contract with Wyoming State Tax Commission so that the said Commission will perform all functions incident to the administration of the Sales Tax Resolution.
5. The amounts subject to the tax created by this Resolution shall not include the amount of any sales or Use Tax imposed by the State of Wyoming.
6. Proceeds of the tax created hereby shall be distributed in accordance with Wyoming law.

RESOLUTION NO. 1982-14

RESOLUTION ESTABLISHING COUNTY ROAD

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming (hereinafter referred to as THE BOARD) on the 16th day of November, 1982, required that the establishment procedure for a road known as Mountain View Estates Road, County Road No. 205L, be commenced pursuant to Section 24-3-101; and

WHEREAS, Notice of Location was published three consecutive weeks in three consecutive issues pursuant to the statutes in such case made and provided; and

WHEREAS, the Board requested that protests and claims for damages be submitted; and

WHEREAS, the Board has received none of the same; and
