DIXON SENIOR SERVICES

Residents of Dixon met with the Commissioners to discuss the possibility of constructing a Senior Center in Dixon. Plans for the Center were presented and reviewed. Funding for the project will be considered in the 1982-1983 County Budget.

Three lots are available at this time for a Center site and can be purchased from the Odd Fellows & Rebeccas Lodge for the sum of \$10,000.00.

A motion was made by Lemich, seconded by McMahon and unanimously carried to purchase the three lots in Dixon for \$10,000.00.

ENCAMPMENT SENIOR CENTER

Loma Robbins stated that the Upper Platte Valley Energy Commission would grant \$5,000.00 toward a solar addition to the Encampment Senior Center. Permission to pursue the project was granted by the Commissioners. There will be no cost to the County.

COUNTY ROAD 291

A delegation from the Leo area made an appeal to the Commissioners to upgrade County Road 291 by raising, graveling and eventually oiling approximately 11 miles. They stated that the road is deteriorating and becoming increasingly hazardous.

The Commissioners will take the matter under advisement.
