CARBON COUNTY JOINT POWERS BOARD

A motion was made by Lemich and seconded by McMahon to adopt the following Resolution:

RESOLUTION 1982-2

WHEREAS the Board of County Commissioners of Carbon County, Wyoming, a body politic and corporate, desires to enter into an Amendment to the Carbon County, Wyoming-Town of Hanna, Wyoming Impact Joint Powers Agreement dated June 2, 1976, in order to enlarge the purpose and powers thereof;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Carbon County, Wyoming that the chairman of said board and the County Clerk of Carbon County, Wyoming are hereby authorized to enter into the attached Agreement on the part of the Board of County Commissioners of Carbon County, Wyoming.

A motion was made by Lemich and seconded by McMahon to amend the Carbon County, Wyoming - Town of Hanna, Wyoming Impact Joint Powers Agreement as follows:

AMENDMENT TO CARBON COUNTY, WYOMING-TOWN OF HANNA, WYOMING IMPACT JOINT POWERS AGREEMENT

THIS AMENDMENT is entered into on the ____ day of _____, 1982, by and between the TOWN OF HANNA, a Wyoming municipal corporation situate in Carbon County, Wyoming, hereinafter referred to as "Hanna" and CARBON COUNTY, WYOMING, a body politic and corporate, situate in the State of Wyoming, hereinafter referred to as "Carbon County."

WHEREAS, the parties hereto previously entered into the Carbon County, Wyoming-Town of Hanna, Wyoming Impact Joint Powers Agreement dated June 2, 1976 for the limited purpose of providing an orderly and economical method of jointly planning, creating, expanding, financing, and operating systems for the delivery of adequate water and sewage services to the residents of Hanna, Wyoming; and

WHEREAS it is the desire of the parties to said agreement to enlarge the purpose of said agreement and the Joint Powers Board existing pursuant thereto to encompass the construction, operation and maintenance of a recreational complex within the Town of Hanna;

NOW, THEREFORE, in consideration of the mutual promises, covenants and agreements herein, it is understood and agreed between the parties as follows:

1. PURPOSE AMENDED. The purpose of the Carbon County, Wyoming-Town of Hanna, Wyoming Impact Joint Powers Agreement and the Joint Powers Board created and functioning thereunder is amended to include, in addition to all powers and purposes previously granted thereunder, the additional purpose and power to construct, operate and maintain a recreation complex in the Town of Hanna deemed by the Board to be appropriate to fulfill the recreational needs and desires of the residents of Hanna. Toward that end, the Joint Powers Board created pursuant to the original Impact Joint Powers Agreement is hereby expressly authorized to exercise all of the privileges and powers granted to it in the original Impact Joint Powers Agreement in the furtherance of the purposes set forth herein.

2. REVENUE AND DEBT RETIREMENT. In addition to the provisions of Section 7 of the original Impact Joint Powers Agreement, it is specifically provided hereby that all revenues from any source collected by the Joint Powers Board in conjunction with its activities pursuant to the purposes set forth herein, including but not by way of limitation, user fees and donations from private sources, are hereby pledged insofar as they may be required for the retirement of indebtedness incurred in the furtherance of the purposes of this agreement.

A motion was made by Lemich, seconded by McMahon and unanimously carried to authorize the expenditure of \$4,000.00 to the Carbon County-Hanna Joint Powers Board for a soil test of the proposed site for the Hanna Recreation Center.

CARBON COUNTY FAIRGROUNDS

A motion was made by Lemich, seconded by McMahon and unanimously carried to execute a Right-of-Way Easement from Carbon County to Pacific Power & Light Company over a portion of the NW¼, Section 16, Township 21, North, Range 87 West of the 6th P.M. Said easement will facilitate the extension of services for new lighting at the Fairgrounds.

WILDLAND FIRE CONTROL

A motion was made by Lemich, seconded by McMahon and unanimously carried to approve the Wildland Fire Control annual Operating Plan between Carbon County, Wyoming State Forestry Division, the USDA Forest Service and the USDI Bureau of Land Management. The Plan is on file in the office of the County Clerk.

CARBON COUNTY SENIOR SERVICES

An application for a \$1,000.00 Grant from the State under Title III of the Older American Act of 1965

March 16, 1982

(as amended 1978) was executed by the Board. The money will be used by the Carbon County Senior Services, Inc. for workshop and staff travel.

CARBON COUNTY WEED & PEST

A motion was made by Lemich and seconded by McMahon to deny a claim made by a letter from Attorney Charles E. Graves on behalf of Mr. & Mrs. Larry Wright against the County for \$600,000.00. The motion was unanimously carried.

MEDICINE BOW AMBULANCE SERVICE

A motion was made by McMahon and seconded by Grieve to allow \$1,276.00 for five pagers for use by the Medicine Bow EMT's. The pagers will be a part of the Medicine Bow Clinic inventory.

There being no further business, the meeting was adjourned.
