DOG RESOLUTION

A motion was made by Lemich, seconded by York and unanimously carried to adopt the following resolution:

RESOLUTION 1983 - 7

A RESOLUTION DECLARING THE RUNNING AT LARGE OF DOGS IN UNINCORPORATED AREAS OF CARBON COUNTY A NUISANCE, PROVIDING FOR NOTICE OF SUCH DECLARATION AND PROVIDING FOR PENALTIES FOR VIOLATIONS.

WHEREAS the County has been granted certain authority under Wyoming Statutes Section 11-31-301, 1977, as amended, to regulate dogs running at large and;

WHEREAS the Board of County Commissioners desires to implement provisions of such statute;

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Carbon County, Wyoming as follows:

1. The Board of County Commissioners hereby declares that the running at large of dogs, as that term is defined in Paragraph 2 of this Resolution, in the unincorporated areas of Carbon County is a public nuisance and is unlawful.

2. For the purpose of this Resolution, "running at large" shall refer to a dog that has run or injured a game animal or livestock, or that has run or threatened a person.

3. It is not an element of the offense of "dog running at large" that the owner or custodian of the dog directed or permitted the dog to run at large. The mere fact that a dog is running at large, as that term is defined herein, imposes criminal liability on the owner or custodian of the dog.

4. A fine shall be imposed on the owner or custodian of any dog found to have been running at large. A first conviction is punishable by a fine of not more than fifty dollars (\$50.00). Each subsequent conviction is punishable by a fine of not more than one hundred dollars (\$100.00). In the case of an attack by a dog on a person in a vicious manner, the penalty in paragraph eight (8) shall apply.

5. Any dog found in an unincorporated area of the County, whose ownership cannot be determined within three days, may be destroyed by the county sheriff after such three day period.

6. A dog found in the act of running or injuring a big game animal may be killed by a peace officer. In an action brought by the state under this resolution, if a court of law determines that a dog was in fact running or injuring a big game animal, then such court may issue an order that the dog be killed by a peace officer, and such court may also order the owner or custodian of such dog to pay restitution to the Game and Fish Department.

7. A dog found in the act of injuring or killing livestock may be killed by the owner of the livestock or his agent or any peace officer. In an action brought by the state under this resolution, if a court of law determines that a dog was in fact injuring or killing livestock, then such court may issue an order that

the dog be killed by a peace officer, and such court may also order the owner or custodian of such dog to pay restitution to the owner of the injured or killed livestock.

8. Any dog found attacking any person in a vicious manner may be destroyed by any other person. The owner or custodian of any dog that has attacked a person in a vicious manner may be fined not more than two hundred dollars (\$200.00). Proof of the fact that the dog has bitten or attacked any person at any place where a person is legally entitled to be is evidence that the dog is vicious within the meaning of this resolution. In an action brought by the state under this resolution, if a court of law determines that a dog did in fact attack a person in a vicious manner or did run, threaten or injure a person, then such court may issue an order that the dog be killed by a peace officer.

9. This Resolution may be enforced by issuance of a citation by a peace officer, or by other means as provided by law.

10. Notice of this declaration shall be published in the Daily Times of Rawlins, Wyoming, a newspaper of general circulation within the county, once a week for two (2) weeks.

11. This Resolution shall be effective from and after the date of the second publication as above provided.




