## CARBON COUNTY AGENT

Mary Gruenewald, Carbon County Home Economist and County Director informed the Commissioners of her resignation effective September 2, 1983.

A motion was made by Lemich, seconded by York and unanimously carried to execute the following agreement:

A G R E E M E N T

THIS AGREEMENT, made and entered into by and between the Agricultural Extension Service of the University of Wyoming, hereafter referred to as the "University", and the Board of County Commissioners of Carbon County, hereafter referred to as the "County",

## WITNESSETH:

WHEREAS, it is desired by the County and the University to improve the County Extension program delivery system through the use of computer technology, under the Federal Smith-Lever Act and the State Acceptance Act of 1915 and amendments thereto covering Extension work in Agriculture, Home Economics, 4-H, and Community Development, and that said work shall be done and directed under the supervision of the Associate Director of the Agricultural Extension Service of the University of Wyoming.

NOW, THEREFORE, for and in consideration of the covenants and agreements of each to the other running, and for other good and valuable consideration, as herein contained, the said parties agree as follows:

That each party to this Agreement shall contribute to the support of the County microcomputer system and program, the cash sum, equipment, and services indicated by the following schedule:

## CONTRIBUTIONS

## WILL PROVIDE:

- (1) Software support including programs for 4-H enrollment, FAIRPAK, word processing, mail lists, and other office management programs;
- (2) Problem solving programs for agriculture producers and families developed by the University of Wyoming;
- (3) Service and backup support for both hardware and software;
- (4) Training for County personnel, Agents, secretaries, and program assistants.

## WILL PROVIDE:

\$5,000 for each County office in which a system is installed, payable according to the following schedule:

\$ \_\_\_\_\_ from the FY-83 budget;

\$ \_\_\_\_\_ from the FY-84 budget;

\$ \_\_\_\_\_ from the FY-85 budget;

AND,

an annual payment of \$600 per system for maintenance of County hardware beginning in FY-84.

On or before July 1 of each year, the County agrees to make its payments for hardware as set out in the schedule above, and to pay \$600 annual maintenance assessment per system to the University. The University agrees to purchase a microcomputer and peripheral equipment for the County to be housed in the County Extension office and/or offices; and further agrees to provide maintenance and repair from time to time as the need may arise. The University will not be responsible for latent defects, wear and tear, or gradual deterioration or loss of service or use of said equipment.

THE TERMS AND CONDITIONS OF THIS AGREEMENT shall be and remain in full force and effect from July 1, 1983 until terminated by mutual consent of the two parties involved.

In the event this Agreement is terminated, the microcomputer and peripheral hardware purchased under said Agreement will become the sole property of the County.

IN WITNESS WHEREOF, the Board of County Commissioners of Carbon County, has caused this Agreement to be executed by its Chairman on this 2nd day of August, 1983, and the University of Wyoming has caused the same to be executed by the President of the University of Wyoming on this day of \_\_\_\_\_, 19 \_\_\_\_.

## CARBON COUNTY PUBLIC HEALTH

The Commissioners made a request to the Wyoming Division of Health and Medical Services to consider a fifth public health nurse in Carbon County to start July 1, 1984. If the position is approved by the State Legislature the County will consider funding 50 percent of the additional budget needed. The Commissioners also requested that the new position be stationed in Hanna.

Case No. 76-14 - Final Plat - Donald Calvert, Hanna, WY 82327, final plat approval for a subdivision located west of Hanna, WY, that has been developed since 1976, and only approved by the Planning Commission recently with the submission of easements, and appropriate road construction. Site is legally described as the NW¼, NW¼ Section 18, Township 22 North, Range 81 West, Carbon County, WY.

A motion was made by Lemich, seconded by York to apply for a Coal Tax Grant thru Farm Loan Board funding in the amount of \$265,125.00 to assist in renovating a portion of Carbon County Road 291.
