PETITION TO ESTABLISH A COUNTY ROAD

A petition was presented to the Board to establish as County Roads those highways as established in that certain plat recorded December 27, 1977 as instrument No. 608377 in Book 600 at Page 23 of the records of Carbon County, Wyoming and known as Cherokee Meadows Subdivision, in Section 31 and 32, T15N, R83W, of the 6th P.M., Carbon County, Wyoming.

A motion was made by York, seconded by Lemich and unanimously carried to appoint Arthur Greene a viewer for said roads.

AGREEMENT for
COAL TAX FOR IMPACT ASSISTANCE ACCOUNT GRANT

The State of Wyoming, acting by and through the Wyoming Farm Loan Board, on the 13th day of October, 1983, in the normal course of business, acting in accordance with the provisions of W.S. 39-227.10(e), authorized a grant in the amount of --TWO HUNDRED SIXTY FIVE THOUSAND ONE HUNDRED TWENTY FIVE----- (\$265,125.00) subject to the availability of funds Carbon County Commissioners (hereinafter the "Grantee") from the Coal Tax for Impact Assistance Account.

The Wyoming Farm Loan Board agrees to furnish said granted funds only as needed to discharge obligations incurred by the Grantee; and requests for disbursements of said funds shall be supported by adequate proof by the Grantee that such obligations have been incurred for the purpose for which the grant was made, and are then due and owing.

The Grantee agrees that the granted funds are to be spent only for the following described purpose or project, and for no other project or purpose, to-wit: Upgrade County Road 291.

If any of the granted funds are not utilized for the above-described project or purpose, the Grantee shall repay such funds immediately to the Wyoming Farm Loan Board.

The Grantee further agrees to provide the Wyoming Farm Loan Board with a full and complete accounting as to the use and distribution of the granted funds; said accounting to be done in accordance with generally accepted accounting principles and shall be provided the Wyoming Farm Loan Board within a reasonable time upon request. The Grantee further agrees that all granted funds shall be received in and disbursed from a separate bank account established only for said granted funds.

The Grantee further understands and agrees that the Wyoming Farm Loan Board may perform an audit or examination of the books and records of the grant at any time and without notice, and that said Board or its designee may at any time without notice perform on-site visits and inspections of the project being funded.

The Grantee further understands and agrees that the above-described grant is subject to the following condition(s):
