DESIGNATION OF DEPOSITORIES

A motion was made by Lemich, seconded by Grieve and unanimously carried to appoint Neil Kirk to the Carbon County Planning and Development Board for a five year term beginning 12/4/82 thru 12/4/87.

CARBON COUNTY ROAD & BRIDGE

Frank Smith, Road & Bridge Supervisor, presented the monthly reports for the Department to the Commissioners.

A motion was made by Lemich, seconded by Grieve and unanimously carried to accept the low bid of Rawlins Sand and Gravel for screening 45,000 tons of gravel at \$1.30 for a total of \$58,500.00.

A motion was made by Lemich, seconded by Grieve and unanimously carried to approve an underground and utility permit for Northwest Pipeline Corporation to install a natural gas line across CR701 at SE4NE4, NE4SE4, Sec. 32, T18N, R83W, 6th P. M.

LIQUOR LICENSE MORITORIUM

A motion was made by Lemich, seconded by Grieve and unanimously carried to extend the moratorium on the issuance of new liquor licenses, excepting from the moratorium the 24 hour malt beverage permits, for an additional year commencing January 1, 1983 and ending December 31, 1983.

JEFFREY CENTER BOARD

A motion was made by Lemich, seconded by Grieve and unanimously carried to reappoint Fred Roberts, Jr. to the Jeffrey Center Board for a five year term beginning 12/4/82 thru 12/4/87.

CARBON COUNTY PLANNING AND DEVELOPMENT

Public Hearing was held before the Board of Commissioners on the following:

Case #82-42 - Zone Change - Gary D. Buck, P. O. Box 694, Encampment, WY 82325, zone change from RAM (Ranching, Agriculture, Mining) to RD-10 (Residential Development) to allow for the development of one single-family residence on a 10 acre parcel of land east of Encampment. Site legally described as part of Lot 10, Section 5, Township 14 North, Range 83 West, Carbon County.

A motion was made by Lemich, seconded by Grieve and unanimously carried to table case file 82-42. Roll was called with the following results: Lemich, Aye; Grieve, Aye.


Case #82-44 - Zone Change - Ray Jr., and Sharyn Guthridge, 5401 Sagebrush Ave., Cheyenne, WY, zone change from RAM (Ranching, Agriculture, Mining) to RD-40 (Residential Development) to allow for the development of one single-family residence on a 40 acre parcel east of Encampment. Site legally described as NW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 8, Township 14 North, Range 83 West, Carbon County.

A motion was made by Lemich, seconded by Grieve and unanimously carried to approve Case No. 82-44. Roll was called with the following results: Lemich, Aye; Grieve, Aye.

Case #82-45 - Zone Change - John Mixon, P. O. Box 296, Baggs, WY 82321, zone change from RD (Residential Development) to RB (Retail Business) to allow for the development of workshops near Wyoming State Highway 70 east of Baggs, on a two acre parcel. Site legally described as NE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 9, Township 12 North, Range 91 West, Carbon County.

A motion was made by Lemich, seconded by Grieve and unanimously carried to approve zone change from RD to HB on the entire 6.7 acre track owned by John Mixon. Roll was called with the following results: Lemich, Aye; Grieve, Aye.
