CITY OF RAWLINS

Michael W. Sabitini, City Engineer, presented a proposal to the Commissioners for a land trade between the City and County. The trade would transfer Tract 2 of the Airport Road Subdivision from the City to the County. The County would transfer the southerly 15 feet of Lot 18 of the Arrow Industrial Park to the City. To complete an area for area trade the County would also transfer a parcel 87.11 feet by 330.71 feet west of and adjacent to the police storage yard on Daley Street.
