NOTICE OF PUBLIC HEARING

FOR ESTABLISHMENT OF A PROPOSED CEMETERY DISTRICT

Notice is hereby given that a public hearing will be held August 21, 1984, in the Office of the County Commissioners in the Courthouse, Rawlins, Wyoming, at 2:00 P.M. concerning a proposed Cemetery District within Election District 11 Precinct 1 described as follows:

All that territory encompassed within the city limits of Saratoga being part of Sections 10,11, 12, 13, 15 and all of Section 14, Township 17 North, Range 84 West, 6th P.M.

and District II Precinct 2 described as follows:

All that territory embraced within the following Townships and lying outside the Saratoga city limits shall be known as District 11 Precinct 2: A-1 of Sections 1 thru 6, Township 16; all of Townships 17, 18, 19, and 20 North, Range 82 West, 6th P.M.; all of Townships 16, 17, 18, 19 and 20 North, Range 83 West, 6th P.M.; all of Sections 1 thru 12, Township 15; all of Township 16; all of Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, part of Sections 10, 11, 12, 13, and 15 lying outside of the Saratoga city limits, all of Sections 16 thru 36, Township 17; all of Townships 18, 19, 20 and 21 North, Range 84 West, 6th P.M.; all of Townships 15, 16, 17, 18 and 19 North, Range 85 West, 6th P.M.; all of Townships 15, 16, 17 and 18 North, Range 86 West, 6th P.M.; all being in Carbon County.

This special hearing is held pursuant to terms of W.S. 35-8-301 for the purpose of creating a Cemetery District for the Town of Saratoga and lands in the vicinity of Saratoga.

The hearing was held pursuant to the terms of W.S. 35-8-301. No persons appeared to be heard concerning any and all matters affecting the creation of said district.

If within thirty (30) days after the adjournment of this hearing September 20, 1984, written protests, signed by the owners of at least thirty-five percent (35%) of assessed valuation of property within any separate county, city or town or unincorporated area of a school district included in the proposed district, are presented to the Board of County Commissioners, the proposal and the district shall fail.

If the number of written protests is insufficient to defeat the establishment of said district, then the respective county commissioners shall order an election to be held in their respective counties within sixty (60) days after the expiration of the thirty (30) day period.
