All of Sections 5, 6, 7, 8, 17, 18, 19, 20, 29, 30, 31 and 32, Townships 22, 23, and 24 North and all Sections 5, 6, 7, 8, 17, 18, 19, 20, 29, 30, 31 and 32 and that part of Sections 4, 9, 16, 21, 28 and 33 lying and being in Carbon County, Townships 25 and 26 North, Range 77, West, 6th P.M.; all Townships 22, 23, 24, 25, and 26 North, Range 78 West, 6th P.M.; all Townships 22, 23, 24, 25 and 26 North, Range 79 West, 6th P.M.; all Townships 24 and 26 North, Range 80 West, 6th P.M.; all being in Carbon County.

Now, therefore, be it resolved that an election for the purpose of establishing a Rural Health Care District in District 7 Precinct 1 shall be held August 20, 1985.
