CARBON COUNTY FAIR BOARD

A motion was made by York, seconded by Daily and unanimously carried to reappoint Bert Johnson for a five (5) year term, from February 1, 1985 to February 1, 1990.

RAWLINS - CARBON COUNTY AIRPORT BOARD

A motion was made by Daily, seconded by York and unanimously carried to reappoint Sam Kelly, Jr. to a five (5) year term, from February 1, 1985 to February 1, 1990.

CARBON COUNTY FIRE DEPARTMENT

A motion was made by York, seconded by Daily and unanimously carried to execute the following:

MUTUAL AID AGREEMENT FOR FIRE PROTECTION

THIS AGREEMENT, made and entered into on this 1st day of January, 1985, by and between the CITY OF RAWLINS, hereinafter referred to as the "CITY", the COUNTY OF CARBON, WYOMING, hereinafter referred to as the "COUNTY", and the DEPARTMENT OF THE INTERIOR, BUREAU OF LAND MANAGEMENT, hereinafter referred to as the "BLM".

WITNESSETH:

WHEREAS, the County provides for fire protection to the residents and businesses located within the County and outside the municipalities or other towns within the County as authorized by Wyo. Stat. 18-3-509 (1977); and

WHEREAS, the City provided fire protection services for its residents and businesses as authorized by Wyo. Stat. 15-1-103 (a) (xxi) (1977); and

WHEREAS, the BLM, in cooperation with the County and City, attempts to provide limited fire protection services to the areas within the County under its jurisdiction; and

WHEREAS, it is the mutual desire of all parties to this Agreement to formulate a plan to come to the mutual aid of each other in the prevention of fire within Carbon County,

NOW, THEREFORE, in consideration of the foregoing and mutual covenants herein contained, the County, City, and BLM agree as follows:

1. Declaration of Policies: Hereby declared to be the policy of the City, County, and BLM to achieve maximum fire protection for the residences and businesses within the county by undertaking a cooperative effort and providing mutual aid.

2. Definitions: For the purposes of this Agreement, the following definitions shall apply:

(a) Receiving Agency: The receiving agency shall be the agency who receives the initial report and request for assistance in fire prevention.

(b) Responsible Agency: The responsible agency shall be the agency having primary jurisdiction over the area in which the fire protection assistance has been requested.

(i) The City shall have primary jurisdiction over all those areas which are encompassed now or hereinafter within the corporate limits of the City of Rawlins, Carbon County, Wyoming as well as the Rawlins-Carbon County Airport.

(ii) The BLM shall have primary jurisdiction over all those lands which are considered by the BLM public lands and held under their jurisdiction, supervision and control.

(iii) The County shall have the primary jurisdiction over all lands which do not fall under the primary jurisdiction of the City or BLM.

(c) Cooperating Agency: The cooperating agency shall mean any agency that has been requested to provide assistance or mutual aid in fire protection by a responsible agency.

3. Suppression: In the providing of fire protection hereunder, the parties agree that the following procedures shall be followed in providing mutual aid:

(a) Reporting: All calls or requests for fire protection shall be reported immediately by the responsible agency. Upon such report all further actions and instruction shall be issued from the responsible agency.

(b) Initial Suppression: It shall be the responsibility of the responsible agency to undertake actions for initial suppression of any situation reported to the responsible party. A cooperating agency may undertake initial action upon request of a responsible party on behalf of the responsible party. All such requests shall be made from and to the following individuals:

- (i) City - Chief of the City of Rawlins Fire Department or his designated acting.
- (ii) County - Fire Warden of Carbon County or his designated acting.
- (iii) BLM - Fire Management Officer of Rawlins District, Carbon County, Wyoming or his designated acting.

4. Authority: The responsible agency shall hold primary responsibility for fire prevention and will be the command agency responsible for providing all decisions. In the event that the responsible party is not the party providing the initial suppression, the cooperating agency providing such initial suppression shall make all command decisions until the arrival of the responsible agency.

5. Request for Mutual Aid: Requests for mutual aid by a cooperating agency shall be subject to the following terms and conditions:

(a) Eight Hour Limitation: A cooperating agency responding for fire prevention will provide mutual aid on a nonreimbursable basis for a period not to exceed eight hours. In the event that a cooperationg agency provides assistance beyond the initial eight hours, the cooperating agency shall be reimbursed by the responsible agency at the rates provided in Schedule "A" which is attached to this agreement.

(b) Limitation: In no event shall a cooperating agency be required to provide mutual aid when, in the decision of the cooperationg agency, such aid endangers the cooperating agencies responsibility to provide primary fire protection within its primary jurisdiction.

(c) Request for Assistance: Any request for mutual aid from a responsible party to a cooperating agencies shall include a verbal statement of the amount and type of equipment requested, the number of personnel requested, and shall specify the locations to which the equipment and personnel are to be dispatched. It shall be the cooperating agencies sole responsibility and decision as to the type of equipment and number of personnel actually dispatched by the cooperating agency.

6. Limitations Upon Liability: Each of the parties shall hold the other respective parties harmless and indemnify such party against any and all liability, losses, costs, materials used, equipment, damages, suits, actions of claims of any person, firm, corporation or association other than each other which result from the operation or services provided under the terms of this Agreement, including all costs, damages, attorney's fees and other expense in defending any such costs, damages, suits, actions or claims which result hereunder.

7. Miscellaneous: In no event shall "first line City equipment" respond outside of the cooperative limits of the City of Rawlins other than the Municipal Airport.

In no event shall the BLM be responsible to provide mutual aid for "structure, vehicles, aircraft or accident fires." It is the express intention of the parties to this Agreement that the only mutual aid provided by the BLM shall be such assistance as may be requested from time to time or responsibility of the BLM in the fire protection of grass and brush fires.

8. Term: This Agreement shall be effective from and after the date first above written and shall terminate upon the withdrawal of any party of this Agreement.

CARBON COUNTY EQUIPMENT

Equipment rates are set by the State of Wyoming's CM2 Committee and will be published in the Spring of 1985.

A motion was made by York, seconded by Daily and unanimously carried to execute the following:

ANNUAL OPERATING PLAN

This plan between Carbon County, Wyoming State Forestry Division, the USDA Forest Service, and the USDI Bureau of Land Management is dated the 1st day of April, 1985.

A. AUTHORITY: The Authority for this plan is as follows:
WILDLAND COOPERATIVE FIRE CONTROL AGREEMENT
Dated 1st day of February, 1981.

B. SUPPRESSION: Suppression: It is mutually agreed:

1. On all private, state, and federal lands in Carbon County:
 - a. The determination of whether a fire is on or threatening NATIONAL FOREST LAND lies with the USDA FOREST SERVICE.
 - b. The determination of whether a fire is on or threatening public land lies with the USDI BUREAU OF LAND MANAGEMENT.
 - c. Initial suppression action will be taken by a cooperating agency on USFS/private/BLM lands for the benefitting agency upon request. Requests will be made as follows:

USDS forest land - District Ranger

Private Lands - County Fire Warden or other responsible CM2 personnel

Public Lands - Fire Management Officer, Rawlins District, Bureau of Land Management

- d. Where intermingled ownership exists, priority for initial suppression action on state and private lands will be taken by the county when all forces are not committed elsewhere. Second priority of "the closest man" concept. In either case, initial action will be reported by the cooperating agency to the State Forester immediately for further instructions. When state land lies within solid national forest ownership lines, initial attack will be handled by the USDA Forest Service with initial action reported to the State Forester as soon as possible for further instructions.
- e. All fires and initial action will be reported immediately to the benefitting agency and further instruction issued. A fire report must be submitted within 48 hours to the benefitting agency (see Exhibit A).
- f. On state lands, the use of aerial retardant shall be made only at the request of the Wyoming State Forester or the Cheyenne District Forester.
- g. On private lands, the use of aerial retardants shall be made only at the request of the County Commissioners and the County Fire Warden.
- h. Cooperators will take initial action on fires occurring on public lands administered by the BLM. Cooperators, BLM, or a combination of both, will then take total suppression action. Authority must be acquired from the Rawlins District Office for the use of aerial retardant or heavy earth moving equipment on public lands administered by the BLM.
- i. No aerial retardant will be used on NATIONAL FOREST LANDS without prior approval by the USDA FOREST SERVICE.

C. REIMBURSEMENT BY BENEFITTING AGENCY

1. The cooperating agency(ies) will submit an itemized bill to the benefitting agency within 20 days after the fire is out.
2. Fires on national forest lands and public lands administered by the BLM.

Cooperating Agencies:

Federal Agencies: Use SF 1081 (voucher and schedule of withdrawals and credits), include fire name and number.

County and State Agencies: Submit an itemized bill (Exhibit B).

3. Fires on state or private lands.

Cooperating Agencies:

- . Federal Agencies: Submit an itemized bill (Exhibit B).

County and State Agencies: Submit an itemized bill (Exhibit B).

4. Salaries for federal/state/county employees will be paid at the established rate in effect for that individual at the time of the fire.
5. Salaries for other than federal/state/county employees will be paid by the applicable AD rate established annually for the western area. (See Enclosure #1 to the Wildland Cooperative Fire Control Agreement).

*This rate is set and will henceforth be established by the Department of Labor, Wage and Rate Division and published yearly with the new CM2 rate sheet.

6. Support equipment rates for federal/state/county equipment will be those rates in effect for each specific piece of equipment at the time of the fire.

*This rate is negotiable and will henceforth be established by the Fire Advisory Board and be published yearly with the CM2 rate sheet.

7. CM2 equipment rates are those contained in Enclosure #1 to the Wildland Cooperative Fire Control Agreement.

8. Aerial chemical fire retardant and other aircraft use will be reimbursed by the benefitting agency at the rate in effect at the time of the fire.

9. When a fire burns on protective units of the parties involved in the agreement, the expenditures for suppression will be adjusted on the basis of the proportional acreages burned.

D. OTHER CONDITIONS

1. This plan becomes effective on the date signed by the last agency. It may be terminated by mutual agreement or on 20 days written notice from one party to the other.

2. This plan will be reexecuted on later than April 15, as called for in the Wildland Cooperative Fire Control Agreement.

3. Federal agencies will send all cooperating agencies copies of their fire mobilization plans. County will send all cooperating agencies a list of their equipment and locations of said equipment.

4. Due to physical fitness, fire training, and safety clothing requirements of the Federal Government, reimbursement in county organizations (i.e., county employees, CM2 participants, volunteer or rural fire departments, and local volunteers) by the Bureau of Land Management will be by an itemized bill as attached in this agreement. The above county organizations are not covered under Federal Workmen's Compensation unless they meet these physical fitness, training, and/or fire experience requirements, and are signed up as federal employees.

5. Any fire which may threaten Bureau of Land Management land must be reported to the above agency at the time equipment is dispatched. This will help insure proper assistance from the Bureau of Land Management.

6. Any fire which may occur where the Bureau of Land Management and Carbon County fire units are operating together, will be considered a mutual aid fire. On mutual aid fires, no matter what the ownership of the land, the first twelve hours of firefighting operations will be on a nonreimbursable basis. After the first twelve hours, the agency responsible for the protection of the land will be billed for any ongoing firefighting assistance.

7. Wildfires resulting from prescribed fires which escaped and which are ignited by or at the direction or under the supervision of one of the parties to this agreement shall be the responsibility of that party. All suppression costs shall be borne by the responsible party. A party may take appropriate suppression action when lands under its protection jurisdiction are involved in or threatened by the fire. Such suppression action may be taken on its own initiative or at the request of the responsible party. A party may take appropriate suppression action, at the request of the responsible party, when lands under its protection jurisdiction are not involved in or threatened by the fire. The responsible party shall reimburse the other party for all suppression costs incurred in accordance with this clause.

8. For the 1985 fire season a limited suppression has been developed which will effect southern and northern parts of Carbon County. Upon completion of this document the county will be supplied with a map of the effected area and a copy of the plan.

A motion was made by Daily, seconded by York and unanimously carried to execute the following:

LEASE AGREEMENT (GRAVEL)

THIS AGREEMENT, made and entered into this 10th day of December, 1984, by and between Carbon County, Wyoming, (lessee) acting by and through its Board of County Commissioners and Umbrella Ranch Inc. (Harry E. Russell III) (lessor) of Carbon County, State of Wyoming.

The lessor hereby warrants that he/she has the full legal authority to be signatory to this lease, and hereby grants the authority to Carbon County to remove sand & gravel from the following described land: W $\frac{1}{2}$ Section 3, Township 12 North, Range 90 West, 6th P.M.

Carbon County hereby agrees to pay the sum of 20 cents per ton for all aggregate removed. Payments to be made on a quarterly basis.

The above described land and use is leased from December 10, 1984 until December 10, 1985. Carbon County shall have the right to re-negotiate this lease 90 days prior to its expiration, if so desired.

Carbon County shall have the right to erect such temporary structures, set up equipment (crushers, hot plants, etc.) build roads, set cattleguards, install fences, gates and use such equipment as is necessary to perform the mining and production of aggregate, on the above described premises.

Carbon County agrees to provide the necessary insurance for the operation of an aggregate mining and production facility, and to hold the lessor totally harmless in any and all areas. Due to the use of the premises by Carbon County.
