FIRE DEPARTMENT

HANNA SEARCH AND RESCUE

Representatives of the Hanna Search & Rescue met with the Board to discuss the purchase of radio equipment. The request was taken under advisement.

ROAD & BRIDGE

A motion was made by York, seconded by Daily and carried to execute a gravel lease agreement between Carbon County (lessee) and Umbrella Ranch, Harry E. Russell III (Lessor). The lease is on file in the office of the County Clerk.
