CARBON COUNTY CHAMBER OF COMMERCE

Members of the Committee to place the 2% lodging tax proposition on the ballot met with the Commissioners. The required number of names (632) submitted by petition, were verified by the County Clerk. A motion was made by Daily, seconded by York and unanimously carried to adopt the following resolution:

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS

OF CARBON COUNTY, WYOMING

CONCERNING PROPOSED CARBON COUNTY LODGING TAX

WHEREAS, a lodging tax has been proposed for Carbon County, Wyoming consisting of an excise tax of 2% for money spent on transient lodging and hotels, motels, tourist courts, trailer parks, campgrounds, dude ranches, and short-term condominium rentals, and

WHEREAS, those who will be paying the tax will be the people staying the above lodging facilities, and such tax will not be a general levy upon the citizens of Carbon County, Wyoming, and

WHEREAS, the funds raised from the lodging tax will be used for tourist promotion of Carbon County, Wyoming, and Carbon County needs a consistent source of revenue for tourist promotion, as the Wyoming State Government, the Carbon County Commissioners, and the Municipalities in Carbon County, Wyoming, cannot be expected to provide the same level of funding as in the past due to decreased economic vitality of Carbon County and of Wyoming, and

WHEREAS, tourism is an important facet of the economic health and vitality of Wyoming and Carbon County, and

WHEREAS, if a 2% tax is approved by the voters of Carbon County, Wyoming, it could raise substantial sums annually in Carbon County, 90% of which would be required to be used to promote tourism, with the remainder to be used as the County Commissioners direct, with the proposed lodging tax to be collected by the owners of the lodging facilities, and

WHEREAS, the proposed lodging tax would create a new source of funding for tourism and decrease the tax burden upon the citizens of Carbon County, Wyoming, and

WHEREAS, the Carbon County Commissioners have received what the Carbon County Clerk has certified as a petition requesting an election on the proposed 2% lodging tax signed by at least 10% of the electors of the County;

NOW, THEREFORE, IT IS HEREBY RESOLVED that this Board of County Commissioners of the County of Carbon approve a special election on the proposed 2% tax contingent upon all requirements for such an election required by the Wyoming statutes be first fulfilled.

LIQUOR MORATORIUM

A motion was made by York, seconded by Daily and carried to extend the moritorium on the issuance of new liquor licenses excepting from the moritorium the 24-hour malt beverage permits, for an additional year commencing January 1, 1987 and ending December 31, 1987.

DEPOSITORY FOR CARBON COUNTY FUNDS

A motion was made by Daily and seconded by York to adopt the following resolution:

R E S O L U T I O N 1 9 8 6 - 6

WHEREAS, Wyo. Stat. § 9 - 4 - 821 (b) (1977) grants to the Board of County Commissioners of the County of Carbon the power to define appropriate collateral for the safekeeping and payment of deposits of public monies and the interest thereon, and

WHEREAS, as the result of concerns of the Commissioners about the kinds of collateral that the County has historically accepted for such purpose, the County Commissioners recently adopted a policy severely limiting the type of acceptable collateral, and

WHEREAS, financial institutions of the County have urged the Commissioners to modify and expand the types of acceptable collateral;

NOW, THEREFORE, BE IT RESOLVED as follows:

1. Carbon County, Wyoming shall accept as collateral for its deposits in addition to the bonds specified in Wyo. Stat. &9-4-820 (1977) and Federal Insurance Corporation or Federal Savings and Loan Insurance Corporation insurance to the extent of \$100,000.00, the following:

(a) United States treasury bills; United States treasury notes; United States Treasury bonds;

(b) Federal Land Bank bonds;

(c) Federal National Mortgage Association notes;

- (d) Debentures, and Guaranteed Certificates of Participation;
- (e) Real estate mortgages insured and debentures issued by the Federal Housing Administration which are unconditionally guaranteed by the United States Government;
- (f) Federal intermediate credit bank debentures;
- (g) Federal home loan bank notes and bonds;
- (h) Bank for cooperative debentures;
- (i) Obligations of or fully guaranteed by the government national mortgage association;
- (j) Federal Housing Administration debentures;
- (k) Bonds and notes of local urban renewal or public housing agencies fully supported as to principal and interest by the full faith and credit of the United States pursuant to Section 302 (42 U.S.C.A. §§ 1421a, 1452) of the Housing Act of 1961;
- (l) Farm Credit System bonds;
- (m) General obligation bonds of Carbon County, Wyoming issued by virtue of the laws of this State worth not less than their par value and in an amount equal at least to the maximum amount of money at any time to be deposited with the financial institution;
- (n) Bonds of any State, County, City, Community College District, or School District in an amount equal at least to the maximum amount of money at any time to be deposited with the financial institution which are escrowed by the U.S. Government guaranteed securities; or
- (o) Warrants issued by Carbon County, Wyoming.

2. Such collateral shall be in an amount that when combined with the FDIC or FSLIC insurance shall provide full collateralization for the principal and all accrued and accruing interest on all County funds deposited with such financial institution.

3. Whenever it shall be necessary for a joint custody receipt to be used to effectuate this collateralization, the joint pledge form promulgated by the office of the State Examiner shall be used, a current copy of which is attached hereto as Exhibit "A".
