CARBON COUNTY FAIRBOARD

A motion was made by York, seconded by Grieve and unanimously carried to reappoint George Sheehan for a five (5) year term, beginning February 1, 1986 and ending February 1, 1991.

CARBON COUNTY TOURIST INFORMATION CENTER

A motion was made by York, seconded by Grieve and unanimously carried to endorse the proposed Carbon County Tourist Information Center and to commit funding (actual expenditure or in kind), contingent upon approval of State financing for the proposed state portion.

CARBON COUNTY ROAD & BRIDGE

Sealed bids were received for a self propelled chip spreader.

GRANT NO. MRG.557 CARBON

A motion was made by York, seconded by Grieve and unanimously carried to execute an agreement between the State of Wyoming, Wyoming Farm Loan Board and Carbon County for Government Royalty Impact Assistance Account Grant in the amount of \$226,300.00 for a County Equipment Building. The agreement is on file in the office of the County Clerk.

HANNA-CARBON COUNTY JOINT POWER BOARD

A motion was made by York, seconded by Grieve and unanimously carried to appoint Howard Epperly to the Hanna Carbon County Joint Power Board, for a three year term. Beginning January 21, 1986 and ending November 1, 1988.


RAWLINS RECREATION CENTER
