#### CARBON COUNTY PLANNING & DEVELOPMENT

A motion was made by York, seconded by Daily and unanimously carried to amend the minutes of December 2, 1981 concerning Case No. 81-23, which was inadvertently omitted.

Action on Case No. 81-23 was as follows:

A motion was made by McMahon and seconded by Lemich to approve Case No. 81-23.

Case No. 81-23 - Zone Change - Katherine Wood, Box 1286, Evansville, WY 82636,  
zone change from RAM (Ranching, Agriculture & Mining) to RD-20 (Residential Development) on a 40-acre parcel of land in the Pedro Mountain Ranches area to allow for the construction of up to two recreational home sites. The site is legally described as Lot 156 in the NW $\frac{1}{4}$  SE $\frac{1}{4}$  Section 11, Township 27 North, Range 84 West, Carbon County, Wyoming.

Case No. 85-33 - To amend the Carbon County Zoning Resolution of 1972, specifically Section 320, adding an item in subsection 324.1, which would allow the county to designate a more specific acreage per dwelling unit to avoid potential illegal subdivision creation.

A motion was made by Daily, seconded by Grieve and unanimously carried to remove Case No. 85-28 from the table.

A motion was made by Daily and seconded by Grieve to approve Case No. 85-28.

Case No. 85-28 - Zone Change - Nels Anderson and John Kranich, W. 296 N. 7074 Tamron Court, Hartland, WI 53029. Zone change from RAM (Ranching, Agriculture & Mining) to RD-25 and RD-26.15 (Residential Development) for a 51.15 acre parcel in the NE $\frac{1}{4}$  SW $\frac{1}{4}$  and tracts in the SW $\frac{1}{4}$  NE $\frac{1}{4}$  and SE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 34, Township 19 North, Range 85 West 6th P.M. with the stipulation that the County Commissioners would not entertain requests for improvement and or maintenance for the access road leading into this property.

Roll was called with the following results: Grieve, aye; Daily, aye; York, absent.


