WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Rawlins Daily Times, a legal newspaper published and of general circulation in the county on the first day of July, 1987 and

WHEREAS, a public hearing was held on such budget at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard; and

WHEREAS, following such public hearing certain alterations and revision were made in such proposed budget, all of which more fully appear in the minutes of this Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget for the fiscal year ending June 30, 1988.

BE IT FURTHER RESOLVED, that the following appropriations be made for the 1987-88 fiscal year ending June 30, 1988 and that the expenditures of each officer, department or spending agency be limited to the amount herein appropriated.

MOUNTAIN BELL


Cliff Barnhart, Mountain Bell representative met with the Commissioners to discuss updating the County telephone system.
