RESOLUTION EXPRESSING THE SUPPORT FOR THE CONTINUATION OF THE 1985 INDUSTRIAL SITING COUNCIL PERMIT ISSUED FOR THE AMOCO BAIROIL CO2 INJECTION PROJECT, WITH SAID PERMIT REMINING APPLICABLE FOR PHASE II OF THE PROJECT.

WHEREAS, the Carbon County Board of Commissioners was actively involved in the Industrial Siting Council's permitting process in 1985 when Amoco was originally permitted for the Bairoil CO2 Injection Project; and

WHEREAS, all of the various impacts of the projects, including those that will arise during Phase II of the project were discussed and addressed during the original permitting process for the project; and

WHEREAS, Amoco has been a good corporate citizen of Carbon County and has always been responsive to our concerns and quick to act when any problems arose.

WHEREAS, it is our opinion that no further hearings are necessary on the project at this time;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Carbon County, Wyoming endorses the continuation of the 1985 Industrial Siting Council Permit issued for the Amoco CO2 Injection project at Bairoil, thus, making the Industrial Siting Council Permit applicable to Phase II of this project.

A RESOLUTION AUTHORIZING SUBMITTAL OF A PROPOSAL TO THE UNITED STATES DEPARTMENT OF COMMERCE ECONOMIC DEVELOPMENT ADMINISTRATION FOR FUNDS TO ASSIST IN THE CONSTRUCTION OF A TOURIST INFORMATION CENTER IN RAWLINS, WYOMING

WHEREAS, the Carbon County Board of Commissioners has determined that economic development is a priority for this county; and,

WHEREAS, the economy of Carbon County has been in an economic recession during the past few years; and,

WHEREAS, tourism has been pinpointed by the Wyoming Futures Project and economic development experts as growth industry for Wyoming; and,

WHEREAS, Carbon County is located along Interstate Highway 80, one of the most heavily traveled interstate highways in the United States, with approximately five million vehicles passing through Carbon County each year; and,

WHEREAS, Carbon County is located in the south central portion of the state, approximately 150 miles from the nearest Tourist Information Center, and, acts as one of the entrances to the Yellowstone National Park; and,

WHEREAS, a Tourist Information Center would generate new jobs and additional revenue for the county by promoting tourism in this area; and,

WHEREAS, there is money available throught the Economic Development Administration of the United States Department of Commerce to assist in funding the construction of a Tourist Information Center;

THEREFORE, BE IT RESOLVED, by the Carbon County Baord of Commissioners that it hereby authorizes the Carbon County Economic Development Corporation to submit an Economic Development Administration grant proposal to the United States Department of Commerce, Economic Development Administration for the purpose of obtaining \$240,835 to assist in the constroction of a Tourist Information Center to be located on Interstate Highway 80 in Rawlins, Wyoming; and that all requirements for submittal of the grant have been met.




