DESIGNATION OF DEPOSITORYES

A motion was made by Daily, seconded by Graalman and unanimously carried to approve all F.D.I.C. and F.S.L.I.C. associated Federal and State chartered banks and savings and loans in Carbon County as official depositories.

ENCAMPMENT FIRE DEPARTMENT

Joe Remick, fire chief from Encampment requested \$850.00 from the Board to match grant monies coming

December 1, 1987

from the Wyoming State Rural Fire Protection Agency. The funds are to be used to install a more efficient tank on a fire truck being used by the Encampment department.

A motion was made by Daily, seconded by Graalman and unanimously carried to allow \$850.00 from the Encampment area's 1987-88 budget allocation toward the purchase and installation of a tank on the Encampment Fire Department truck.

ROAD AND BRIDGE

Frank Smith, Road and Bridge supervisor gave his report to the Board for the month of November, 1987.

FIRE DEPARTMENT

Danny Schinkel, Carbon County Fire Chief requested permission to perform general maintenance and install safety equipment on various County fire equipment. Permission was given.


PLANNING & DEVELOPMENT
