
CARBON COUNTY FIRE DEPARTMENT

PROCLAMATION AND NOTICE OF SPECIAL ELECTION

ON LODGING TAX

WHEREAS, the Board of County Commissioners of Carbon County have been presented with a petition signed by at least 10% of the electors of the County, based upon the number votes cast at the last general election, and

WHEREAS, the Petition requests that a proposition for the imposition of an excise tax at a rate of 2% upon the sales price paid for lodging services be submitted to the electors of the County, and

WHEREAS, Wyo. Stat. § 39-6-412(d)(1977), as amended, requires that any such election shall be at the direction and under the supervision of the Board of County Commissioners, and subparagraph (e) provides that such proposition may be submitted at any general election or at a special election held for that purpose, and Wyo. Stat. § 22-23-802(1977), as amended, provided that the date of a special election and the location of polling places therefor shall be by proclamation.

NOW, THEREFORE, IT IS HEREBY PROCLAIMED AND NOTICE IS HEREBY GIVEN to the qualified electors of Carbon County that:

On February 10, 1987, a special election will be held within the boundaries of Carbon County for the purpose of submitting to the qualified electors of Carbon County the following proposition:

SHALL CARBON COUNTY BE AUTHORIZED TO ADOPT
AND CAUSE TO BE IMPOSED AN ADDITIONAL 2%
SALES TAX UPON THE SALES PRICE PAID FOR
LODGING SERVICES, THE PRIMARY PURPOSE OF

If, at such election, it shall appear that a majority of the qualified electors voting on the proposition are in favor of adopting the additional 2% sales tax on lodging services, the tax shall be effective commencing February 10, 1987.
