PLANNING & DEVELOPMENT

A Public Hearing was held concerning the application of funds under the Wyoming State Community Development Block Grant Program, Planning Only.

R E S O L U T I O N # 1 9 8 8 - 7

CARBON COUNTY BOARD OF COMMISSIONERS

WHEREAS, public notice of the Public Hearing to discuss the application for a CDBG - Planning Only Grant was published fifteen days prior to the hearing and informed citizens of the dollar amount available, the range of allowed activities and other pertinent information concerning the time and location of the hearing; and,

WHEREAS, citizen participation has been encouraged and provided for with particular emphasis on participation by persons of low and moderate income who are residents of slum and blight areas, and of areas in which CDBG funds are proposed to be used; and,

WHEREAS, Timeline, Incorporated has requested that a CDBG - Planning Only Grant application in the amount of \$18,000 be submitted on their behalf for the purpose of obtaining a market study for the Timeline I.V. product; and,

WHEREAS, should the market study prove the viability of the Timeline product, production of this product will occur in Carbon County, Wyoming and will result in approximately 17 jobs for a county with 5.6% unemployment; and,

WHEREAS, the jobs produced will be primarily for the low and moderate income people and thus will aid in the prevention of slums and blight in Carbon County;

NOW THEREFORE BE IT RESOLVED, that the Carbon County Board of Commissioners on this day, Wednesday, September 7, 1988, hereby endorses the Timeline, Incorporated application for a CDBG - Planning Only Grant for the purpose of obtaining a market study for the Timeline I.V. product, and thereby approves the application for submittal to the Wyoming Economic Development and Stabilization Board for their consideration and anticipated approval.
