Allen Bergstrand, Emergency Management Coordinator discussed various projects ongoing at the Emergency Operations Center (radio room, radio tower and generator installation) and available funds.

REGION VIII, PROJECT REACH, AND CARBON COUNTY CHILD DEVELOPMENT

A panel of representatives met with the Board to discuss financing for the proposed building construction and asked for support from the Commissioners in applying for financial assistance.

PRECINCT ELECTION BOUNDARIES CHANGE

A motion was made by Daily, seconded by Graalman and unanimously carried to adopt the following:

R E S O L U T I O N    1 9 8 8 - 1

WHEREAS, Section 22-7-102, Wyoming Statutes 1977, as amended, provides that the Board of Commissioners at its regular February meeting in every General Election Year shall divide the County into not more than thirty (30) election districts; and

WHEREAS, the proposed changes of precinct election boundaries have been heretofore published in a newspaper of general circulation in Carbon County, Wyoming, as by law required;

WHEREAS, Section 22-7-103, Wyoming Statutes, 1977 as amended, provides that a proposed change in election precinct boundaries may be finalized by the Board of County Commissioners at its regular February meeting and that each precinct shall be designated by number; and

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming finds that the election district and precinct boundaries as hereinafter set forth are conducive to the best interests and convenience of the greatest number of electors involved and said boundaries should be finalized and established as hereinafter set forth;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Carbon County, Wyoming:

1. That the District 6 Precinct 1 and District 16 Precinct 1 election boundaries as set forth below be, and the same are hereby established within Carbon County, Wyoming:

District 6 Precinct 1 - Leo. All that territory embraced within the following Townships shall be known as Election District 6 Precinct 1 - Leo: All Township 25 North, Range 80 West, 6th P.M.; all Townships 25, 26, 27 and 28 North, Range 81 West, 6th P.M.; all Townships 24, 25, 26, 27 and 28 North, Range 82 West, 6th P.M.; Sections 11 and 12 of Township 24 North, Range 83 West, 6th P.M.; Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 34, 35 and 36, Township 25 North, Range 83 West, 6th P.M.; all Townships 26, 27 and 28 North, Range 84 West, 6th P.M.; all being in Carbon County.

District 16 Precinct 1 - Sinclair. All that territory embraced within the following Townships shall be known as Election District 16 Precinct 1 - Sinclair: All Townships 22 and 23 North, Range 83 West, 6th P.M.; Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35 and 36 of Township 24 North, Range 83 West, 6th P.M.; Sections 29, 30, 31, 32 and 33 of Township 25 North, Range 83 West, 6th P.M.; all of Townships 22, 23 and 24 North, Range 84 West, 6th P.M.; all of Townships 20, 21, 22, 23 and 24 North, Range 85 West, 6th P.M.; all of Townships 21, 22, 23 and 24 North, Range 86 West, 6th P.M.; all of Sections 1, 2, 3, 10, 11, 12, 13, 14, 15, 22, 23, 24, 25, 26, 27, 34, 35 and 36 of Townships 22, 23 and 24 North, Range 87 West, 6th P.M.; all being in Carbon County.

#### RADIO TECHNICIAN

Clayton Kilgore, Carbon County Radio Technician updated the Commissioners on the Emergency Operations Center, Road and Bridge, Sheriff and mountain sites with regard to radio equipment.

#### CARBON COUNTY FAIRBOARD

A motion was made by Daily, seconded by Graalman and unanimously carried to reappoint Russell Herring to a five (5) year term beginning February 1, 1988 and ending February 1, 1993 on the Carbon County Fairboard.

#### COUNTY ROADS

Jim Kladianos of the Wyoming State Highway Department reported on available "Farm to Market Road Funds" through the State of Wyoming.

#### COOPERATIVE EXTENSION SERVICE

A panel of representatives from the University of Wyoming met with the Board and other interested parties to explain the changes in the cooperative extension services throughout the State of Wyoming and in particular Carbon County.

#### LITTLE SNAKE RIVER VALLEY AIRPORT

Peter Muller of Muller, Sirhall and Associates, Airport Consultants presented administrative and appraisal contracts for the Commissioner's consideration. The contracts are part of the process in purchasing the lands currently being leased at the Little Snake River Valley Airport.

A motion was made by Daily, seconded by Graalman and carried to authorize James A. York, Chairman of the Carbon County Commissioners to execute three contracts for services connected to the Little Snake River Valley Airport land purchase.

The three contracts were executed (one for administrative services, one for land appraisal, and the third for review of the land appraisal). Copies of the contracts are on file in the office of the Carbon County Clerk.

#### PLANNING AND ECONOMIC DEVELOPMENT


Burl Davis and Bob Bebout, Energy International representatives explained the progress of their industrial development in Carbon County and met in executive session to discuss funding with the Board.
