CARBON COUNTY WEATHERIZATION PROJECT

Gary Garvin of Carbon Power and Light and Brian Arp, the local NOWCAP representative met to discuss a weatherization project for Carbon County residents.

A motion was made by Graalman, seconded by York and carried to seek Community Services Block Grant Discretionary Funds for a Carbon County weatherization project. A request was then executed to the Wyoming Division of Community Programs for the project in the amount of \$12,285.71.

FIRE DEPARTMENT

Danny Schinkel, Carbon County Fire Chief proposed a fireman pension plan for the Carbon County volunteer fireman. No action was taken and more information regarding the plan's operation will be presented at a later date.

ROAD & BRIDGE

An underground utility permit was executed, allowing American Telephone and Telegraph Company to install a fiber-optic communication line along and across Carbon County roads. A copy of the permit is on file in the office of the Carbon County Clerk.

R E S O L U T I O N 1 9 8 8 - 2

The Board of County Commissioners
Carbon County, Wyoming

WHEREAS, the Sinclair Oil Corporation refinery operations represent an important economic asset for Carbon County and substantially benefits the citizens of Carbon County; and

WHEREAS, the Sinclair Oil Corporation is concerned about losing its competitiveness in the oil refinery market should it be required to close its existing landfill which services only the disposal needs of the Sinclair Oil Corporation; and,

WHEREAS, the United States Environmental Protection Agency (EPA) has recently notified Sinclair Oil Corporation of its intent to deny the permit to allow the refinery to continue disposing of its waste at its on-site landfill; and,

WHEREAS, Sinclair Oil Corporation is also trying to obtain permits from the Wyoming Department of Environmental Quality (DEQ) which has set regulations that conflict with those of EPA; and,

WHEREAS, Sinclair Oil Corporation is seemingly being caught in a regulatory struggle between EPA and DEQ, and Sinclair Oil Corporation and other such industrial projects should not be caused to suffer because of such a regulatory struggle;

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Carbon County, Wyoming, at its meeting held on the 16th day of February, 1988, that we respectfully request EPA to rescind its notice of intent to deny a permit for the Sinclair Refinery landfill, and that EPA continue to work with Sinclair officials to resolve this permitting matter.

BE IT FURTHER RESOLVED that we support the enactment of state legislation that would authorize and instruct DEQ to coordinate regulatory and other permitting matters with EPA so as to expedite the permitting process for industrial projects; that a reasonable time should be given to comply with any such regulations; and, that such coordination between DEQ and EPA should not preclude DEQ from having differing regulations from EPA but that the coordination would provide the forum within which to workout such differences so that the applicant industry could receive permitting in a timely manner.


