CARBON BUILDING

The Commissioners approved the purchase of two more airconditioning units for the Carbon Building. The expense will be paid out of the construction fund for that building.

SARATOGA-CARBON COUNTY IMPACT JOINT POWER BOARD

A motion was made by Wille, seconded by Graalman and passed to appoint Dick Bradshaw to fill the term of David Norman on the Saratoga-Carbon County Impact Joint Powers Board. The term will begin November 17, 1989 and ending July 31, 1991.

SHERIFF

County Sheriff, Don Sherrod requested two new cars for his department. The Board approved the purchase of one car.

VENTLING BUILDING

Bob Dahl, with the Rawlins-Carbon County Chamber of Commerce and the Old Pen Board requested \$4,500.00 to insulate the Ventling Building at the Old Pen. The Commissioners will look into the possibility. No action was taken.

Mr. Dahl also reported on rural addressing; Pacific Power & Light will contribute \$5,000.00.

Planning Director, Susan Grafton gave her report for the month of October, 1989.

ROAD & BRIDGE

Road & Bridge representatives, Don Neuman and Patricia Schuler gave a report on the underground fuel tanks.

Neuman discussed the Saratoga Airport improvements and the possible effect on the Spring Creek Road. Also discussed was the use of the City of Rawlins paver on the South road, in exchange for hauling sand to the City.

The Army Corp of Engineers will show a movie on December 1, 1989.

A cattle guard will be installed on County Road 400. Mr. Wallacer, a land owner is against this plan.

The Board approved the hiring of two part-time employees to build cattle guards.

EXECUTIVE SESSION
