R E S O L U T I O N 1 9 8 9 - 1 2

WHEREAS, Carbon County has suffered an unemployment rate greater than the State's average, a loss of population and a deteriorating economic base; and,

WHEREAS, The State Board of Charities and Reform has expressed a need for an additional 200 bed prison facility; and,

WHEREAS, Carbon County has served as the location for the State prison since 1901 and the County is accustomed to the prison and its related impacts; and,

WHEREAS, the location of the new facility next to the existing prison will result in long term cost savings to Wyoming taxpayers, and a more efficient prison network for the State;

NOW THEREOFRE BE IT RESOLVED, that the Carbon County Board of Commisisoners on this day, December 5, 1989, during the regular meeting of the Board, hereby supports and encourages the location of the new 200 bed prison facility in Rawlins, Wyoming.
