## LIQUOR LICENSE MORITORIUM

A motion was made by Graalman, seconded by Wille and unanimously carried to extend the moritorium on the issuance of new liquor licenses excepting from the moritorium the 24-hour malt beverage permits, for an additional year commencing January 1, 1989 and ending December 31, 1989.

## DESIGNATION OF DEPOSITORYES

A motion was made by Wille, seconded by Graalman and unanimously carried to approve all F.D.I.C. and F.S.L.I.C. associated Federal and State chartered banks and savings and loans in Carbon County as official depositories.

## DESIGNATION OF OFFICIAL PAPER

A motion was made by Graalman, seconded by Wille and unanimously carried to appoint the Rawlins Newspapers, Inc. as the official paper of Carbon County.

## RATTLESNAKE PASS ROAD SETTLEMENT

A motion was made by Wille, seconded by Graalman and passed to pay Carolyn Duncan and Harvey Duncan \$597.99 as ordered by the courts.
