County Planner, Susan Grafton updated the Commissioners on the progress of the Tourist Information Center and the rural addressing system.. Also presented at this time was the 1988 Annual Report.

Planning Commission Chairman, Robert Konrath requested funding for a land use study to be conducted by the University of Wyoming. A motion was made by Wille, seconded by Graalman and passed to have the study done at an estimated cost of \$2,700.00.

RESOLUTION 1989 - 8

A RESOLUTION IN SUPPORT OF HOLDING A SPECIAL ELECTION TO DETERMINE IF A TOURIST INFORMATION CENTER MAY BE FINANCED BY OPTIONAL ONE PERCENT SALES TAX INCOME.

WHEREAS, the County of Carbon, Wyoming, obtains a large portion of its economic base from the tourist industry; and,

WHEREAS, there are a large number of tourists passing through the County on Interstate Highway 80 without stopping or becoming aware of the many tourist attractions available within the County; and,

WHEREAS, a tourist information center would encourage more tourists to utilize the wide variety of available facilities to them within the County if such were properly established, designed, located and constructed;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING, that the following question will be presented to the electors of Carbon County at a special election pursuant to § 39-6-412, Wyo. Stat. (1977), to be held on April 24, 1989:

Should Carbon County impose an excise tax of 1% upon retail sales of tangible personal property, admissions, services made, storage, use and consumption of tangible personal property within the County in addition to all other taxes currently imposed? Said tax shall begin on June 1, 1989, and terminate after such time as Six Hundred Fifty Thousand Dollars (\$650,000.00) has been collected to fund the planning, construction, furnishing and equipping of a tourist information center which will benefit all of Carbon County.

RESOLUTION 1989 - 9

A RESOLUTION ENDORSING THE FORMATION OF A JOINT POWERS BOARD FOR THE CARBON COUNTY TOURIST INFORMATION CENTER

WHEREAS, the Carbon County Tourist Information Center will be for the purpose of promoting tourism throughout Carbon County; and,

WHEREAS, the provision to the Tourist Information Center of updated tourist information material about each Carbon County municipality will be the responsibility of individual municipality; and,

WHEREAS, Countywide representation in the Tourist Information Center should be guaranteed since the Tourist Information Center was funded through a Countywide funding source;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CARBON COUNTY, WYOMING, that should the passage of the 1% Optional Sales Tax occur, a Joint Powers Board will be appointed, pursuant to Wyoming Law, for the purpose of the development, administration and ownership of a Carbon County Tourist Information Center. The duties of the Joint Powers Board shall include, but not be limited to, deciding matters relative to the planning, siting, constructing, furnishing and equipping of the Tourist Information Center; and, deciding matters concerning the ongoing operation and maintenance of the Tourist Information Center;

FURTHERMORE, the Joint Power Board will be made up of representatives from each municipality in the County, unless otherwise agreed by the municipality, and a representative of the Board of Commissioners. Each participating governmental entity will be given one vote on the Joint Powers Board.
