A Zone Change on two parcels of land formally zoned RD-10 (Residential Development - 10 acres) to one RD-15 (Residential Development - 15 acres) and one RD-5 (Residential Development - 5 acres) to allow for the sale of the five acre parcel on land legally described as the N $\frac{1}{2}$ NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 4, Township 12 North, Range 90 West, Carbon County, Wyoming.
