BUILDINGS AND GROUNDS

County Building and Grounds manager, Bud Greene requested the hiring of Mow Town to maintain the lawn at the Courthouse for the next six months. The Commissioners approved the request.

CORONER

Zack Rinderer, County Coroner requested a transfer of funds to the Coroner's budget. The budget has been used up by an unusual number of indigent burials and autopsies. An estimated \$8,800.00 is needed to pay expenses to the end of the fiscal year, June 29, 1990. Civil attorney, Wade Waldrip will research the possible transfer.

SELF-INSURANCE

Amy Carlson, representing C.B.S.A. (administrators of the County's self-insurance health plan), updated the Board on the self-insurance program.

LIQUOR LICENSE TRANSFERS

A motion was made by Graalman, seconded by Wille and carried to approve the transfer of County Retail Malt Beverage Permit #1989-14a from Patsy A. Payne dba The Place to Edward C. Faust dba The Place.

A motion was made by Graalman, seconded by Wille and carried to approve the transfer of County Retail Liquor License #1989-7 from Shirley Basin Service Company to Patsy A. Payne dba The Place.

PROPERTY TRANSFER

A bid of \$1010.00 was received from John Dolling for Lot 12 Block 3 of the original Town of Medicine Bow. A motion was made by Wille, seconded by Graalman and carried to accept Mr. Dolling's bid.

PLANNING

County Planner, Susan Grafton and Planning Board member, Harry Russell reported on the land use plan's completion in May and the land fill meeting held in Casper. Also presented were the annual report for the Planning Board and the monthly report for March, 1990.

The Commissioners approved the hiring of contract help for two weeks.

ECONOMIC DEVELOPMENT

Mike Hickman and Susan Grafton, representing the Carbon County Economic Development Corporation, updated the Board on the Prison Project and the Rainbow Ambassadors.

Mr. Hickman requested \$1,109.00 to send Bill Saulcy to San Francisco for the purpose of recruiting. The request was approved.

SNOW REMOVAL

Vera Brinkman and John Bush met with the Commissioners to request funding for snow removal at the Ryan Park snowmobile parking area. Brinkman and Bush were acting as representatives for the Rawlins Rough Riders Snowmobile Club, Inc.

The Board agreed to allocate \$500.00 in the Road & Bridge budget and look for another \$500.00 to meet the \$1,000 requested by the Rough Riders Club.

ROAD AND BRIDGE


County Road & Bridge supervisor, Don Neuman, gave his administrators report. Also discussed were correspondence from Carolyn Duncan and the possible purchase of a re-bar cutter and bender.

It was announced by Road & Bridge office manager, Patty Schuler, that department personnel will be completing C.P.R. training April 11th and 19th.


FIRE DEPARTMENT

A motion was made by Wille, seconded by Graalman and carried to execute an agreement between Carbon County, Wyoming State Forestry Division, the U.S.D.A. Forest Service, and the U.S.D.I. Bureau of Land Management. The purpose of the agreement is an operating plan for cooperative wildland fire control. A copy of the agreement is on file in the office of the County Clerk.

THERE BEING NO FURTHER BUSINESS, the meeting was adjourned.
