## RADIO TECHNICIAN

Clayton Kilgore, radio technician for Carbon County, met with the Commissioners to discuss budgeting for fiscal year 1990-91. His request was for \$118,071.05.

Also presented was a request for \$600.00 to purchase equipment to enable telephone communication from county vehicles.

## SHERIFF

County Sheriff, Don Sherrod reported that Jerry Colson will be the undersheriff and requested the hiring of two jailers. The Board approved the hiring. Also discussed was dispatch service for the Town of Encampment police.

## BAGGS SOLID WASTE DISPOSAL DISTRICT

Jane Hankensen, Don MacAlister and Martin Pederson appeared before the Board with a proposal to enlarge the Baggs Solid Waste Disposal District. At this time they also presented a resolution from the District's board, dated May 10, 1990.

## JACK CREEK ROAD

Saratoga people for the Jack Creek road presented a letter from the Federal Aviation Administration stating F.A.A. may be able to help with funding, but they want the county to start the talks concerning this road. P.M.P.C. consulting engineers gave some proposed cost figures for the road. County Road & Bridge personnel, Don Neuman and Allen Mace talked about their problems with the road. Gary Graalman asked what the people of Saratoga want on this road. Joe Glode said a state highway would be the best place for the trucks. The Commissioners told Don Neuman to write Mr. William E. Moore of the F.A.A. in Denver to get the decision started..

## PERSONNEL

Debbie Weickum, representing Data Processing, asked Gary Graalman's thoughts on raising the deductible on the County's health insurance. Debbie said that it would cost the employees to do that.

## HANNA FIRE DEPARTMENT

Richard Gregory, representing the Town of Hanna Fire Department, needs more funding for the Town of Hanna. The Town would like the County to help pay a full time position at the cost of \$10,000.00.

## K.I.D.S.

David Dischner, representing K.I.D.S., Inc., presented a contract between Carbon County and the State Economic Development & Stabilization Department for the K.I.D.S. housing project grant. County civil attorney, Wade Waldrup spoke on the contract. Dischner discussed the two letters received opposing the housing project and the meeting scheduled to answer the concerns. The Commissioners were invited to attend the noon meeting May 25, 1990.

A motion was made by Graalman, seconded by Wille and carried to execute the contract with the State.

#### MEDICINE BOW HEALTH CENTER

Bill Cooper, representing the Medicine Bow Health Center, presented the proposed budget for the Center.

#### EXTENSION SERVICE

Doug Reynolds, County Agricultural Extension Agent requested funding for studies.

#### HANNA RECREATION CENTER

Peggy Ryckert, representing the Hanna Recreation Center presented a budget request of \$50,000 for fiscal year 1990-91.

#### ROAD & BRIDGE

A motion was made by Graalman, seconded by Wille and carried to deed a parcel of land to TZ Land & Cattle Co. with the following description:

A parcel of land located in the NE $\frac{1}{4}$  of Section 2, Township 16 North, Range 82 West of the 6th P.M., Carbon County, Wyoming, being more particularly described as follows:

Beginning at a point on the South line of the North  $\frac{1}{2}$  of Section 2, Township 16 North, Range 82 West, from which the NE corner of said Section bears N.1 16'25"E. a distance of 4,324.07 feet;

Thence N.51 52'37"W., a distance of 117.64 feet;

Thence N.64 19'43"W., a distance of 119.54 feet;

Thence N.71 51'24"W., a distance of 122.90 feet;

Thence N.83 32'18"W., a distance of 136.58 feet to a point which is the beginning point of the proposed realignment.

The above-described centerline is used to establish a 60-foot right of way being 30 feet on either side of centerline. The above-described parcel of land contains 0.68 acres, more or less. All bearings are referenced to G.L.O. recorded bearings.

Don Neuman, representing the Road & Bridge department, gave his two-week report, discussed a letter received concerning a problem on a county road, and the Rawlins overlook proposal, which he feels will be too costly for the County.


#### SARATOGA AMBULANCE

Don Herold, representing the Town of Saratoga, presented a budget request in the amount of \$7,500 for fiscal year 1990-91.

THERE BEING NO FURTHER BUSINESS, the meeting was adjourned.
