BAGGS SOLID WASTE DISPOSAL DISTRICT

A motion was made by Graalman, seconded by Wille and unanimously carried to approve the following resolution enlarging the Baggs Solid Waste Disposal District:

RESOLUTION NO. 1990-1

WHEREAS, Wyo. Stat. 18-11-101 (1977) grants to the Board of County Commissioner of the County of Carbon the power and authority to add to an existing solid waste disposal district, and

WHEREAS, such a district was created by resolution September 8, 1976, and

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming find that an economic necessity exists for the enlargement of said solid waste disposal district boundaries, and

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming further finds that the district described below is a feasible economic unit to administer and carry out the statutory purposes intended,

NOW, THEREFORE, BE IT RESOLVED that the Baggs Solid Waste Disposal District as created by resolution dated September 8, 1976, shall be enlarged, and that the Baggs Solid Waste Disposal District shall now include all of the following-described lands within Carbon County, Wyoming, to-wit:

BAGGS SOLID WASTE DISPOSAL DISTRICT BOUNDARY

"That portion of Carbon County, Wyoming, bounded by the following described line:

Beginning at the Southwest corner of said Carbon County, the intersection of the West line of Carbon County with the North line of the State of Colorado;

Thence North along the West line of Carbon County to the Northwest corner of Township 19 North, Range 93 West;

Thence East along the County line to the Northeast corner of Township 19, Range 91 West;

Thence South along the East line of Townships 19 and 18 North, Range 91 West, to the Southeast corner of Township 18 North, Range 91 West;

Thence East along the North line of Township 17 North, Ranges 90 and 89 West, to the Northeast corner of Township 17 North, Range 89 West;

Thence South along the East line of Township 17 North, Range 89 West, to the Southeast corner of Township 17 North, Range 89 West;

Thence East along the North line of Township 16 North, Ranges 88 and 87 West, to the Northeast corner of Township 16 North, Range 87 West;

Thence South along the East line of Townships 16, 15, 14, 13 and 12 North, Range 87 West, to the intersection with the South line of Carbon County, and the North line of the State of Colorado;

Thence West along the South line of Carbon County to the point of beginning."

PLANNING/ECONOMIC DEVELOPMENT

Three documents were executed pertaining to the Sand Lake Lodge Community Development Block Grant.

- 1) A contract between Carbon County and Carbon County Economic Development for administering the revolving loan fund for Sand Lake Lodge.
- 2) An agreement between Wyoming Community Development and Carbon County for administration of a Community Development Block Grant (\$15,000) for Sand Lake Lodge.
- 3) A loan agreement between Sand Lake Lodge and Carbon County concerning the Community Development Block Grant.

A motion was made by Wille and seconded by Graalman to approve Case File No. 90-01.

Case File No. 90-01 - Zone Change - Carbon County Planning Commission, Carbon Building, Suite 320, Rawlins, WY 82301. A Zone Change for the Old Baldy Village Subdivision in Section 18, Township 17 North, Range 83 West and Section 13, Township 17 North, Range 84 West, Carbon County, Wyoming, to update the zoning to coordinate with development plans for Old Baldy Village. All of the following is being rezoned from RAM (Ranching, Agriculture, Mining) to RD - 15,000 (Residential Development - 15,000), and is legally described as: all of Block 1, 1st Addition; all of Block 2, 2nd Addition; all of Block 3, 3rd Addition; all of Blocks 3A and 5, 4th Addition; all of Blocks 6, 7 (except Lot 10 in Block 7), 8, and 9, 5th Addition; and all of Block 10, 6th Addition. The following area of land is being rezoned from RAM (Ranching, Agriculture, Mining) to RB (Retail Business), and is legally described as:

Don Neuman, Road Supervisor, reported on the summer job priority list. Also discussed was the Omaha District, Corps of Engineers' rules of construction for a permit involving Fish Creek, East Fork of Fish Creek, Dirtyman Creek and East Fork of Savery Creek. Neuman told the Commissioners the hours Road & Bridge employees will work.

Don Kortes discussed his problem with the Leo Road and the bridge at Lost Creek. Neuman tried to tell him what the Road & Bridge department is going to do. But, Mr. Kortes does not agree because of the beaver.

WHEREAS, said Section 18-3-107, Wyoming Statutes, 1977, also provides that each County Commissioner will be paid such compensation as the Board of County Commissioners determine by Resolution, and that said Board shall meet not later than June 1, 1990, for the purpose of setting their salaries for the following four years, commencing January 1, 1991; and

WHEREAS, the Board of County Commissioners has duly deliberated and discussed the various factors which are determinative of said salaries; and

WHEREAS, the Board has determined that the County Attorney, County Sheriff, County Assessor, County Clerk, Clerk of the District Court, and County Treasurer shall receive an annual salary for the calendar year 1991 in the amount of \$39,000.00, and an annual salary for the calendar year 1992 of \$40,000.00, and an annual salary of \$40,000.00 for the calendar year 1993, and an annual salary of \$40,000.00 for the calendar year 1994, together with the same benefits as accorded other county employees; and

WHEREAS, the Board of County Commissioners has further determined that the Coroner and each County Commissioner whose term shall commence on January 1, 1991, shall be paid an annual salary in an amount of \$12,000.00 in each of the calendar years of 1991 through 1994, and

NOW, THEREFORE, BE IT RESOLVED that the County Assessor, County Clerk, Clerk of the District Court, and the County Treasurer of Carbon County, Wyoming, shall receive an annual salary of \$39,000.00 for the calendar year 1991, \$40,000.00 for the calendar year 1992, \$40,000.00 for the calendar year 1993, and \$40,000.00 for the calendar year 1994. In addition to said monetary compensation, the said elected officers of Carbon County, Wyoming,

shall receive the same benefits as accorded other employees of Carbon County, Wyoming, at the date of the adoption of this Resolution, including but not limited to the same retirement matching contributions from the County as other County employees, and the same coverage under any County insurance policies at the rates accorded other County employees.

BE IT FURTHER RESOLVED, that the Coroner and each of the County Commissioners, with an effective term commencing January 1, 1991, shall be compensated in the amount of \$12,000.00 annually. In addition to said monetary compensation, the said elected officers of Carbon County, Wyoming, shall receive the same benefits as accorded other employees of Carbon County, Wyoming, at the date of the adoption of this Resolution, including but not limited to the same retirement matching contributions from the County as other County employees, and the same coverage under any County insurance policies at the rates accorded other County employees.

BE IT FURTHER RESOLVED, that the salaries herein established shall not be changed during the four-year term of said elective officers.

BE IT FURTHER RESOLVED, that this resolution shall have an effective date of the 15th day of May, 1990.
