UPPER PLATTE VALLEY SOLID WASTE DISPOSAL DISTRICT

A motion was made by Wille, seconded by Graalman and carried to approve the following resolution:

R E S O L U T I O N 1 9 9 0 - 6

WHEREAS, Wyo. State. § 18-11-101 (1977) grants to the Board of Commissioners of the County of Carbon the power and authority to establish a solid waste disposal district, and

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming find that the economic necessity exists for the creation of a solid waste disposal district, and

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, further finds that the district described below is a feasible economic unit to administer and carry out the statutory purposes intended therefor;

NOW, THEREFORE, BE IT RESOLVED that the Upper Platte Valley Solid Waste Disposal District is hereby created and shall include all of the following-described lands within Carbon County, Wyoming, to-wit:

All those lands described on Exhibit "A", which Exhibit is attached hereto and by this reference incorporated herein.

EXHIBIT "A"UPPER PLATTE VALLEY SOLID WASTE DISPOSAL DISTRICT

"That position of Carbon County, Wyoming bounded by the following described lines:

Beginning at the Southeast corner of said Carbon County, the intersection of the East line of Carbon County with the North line of the State of Colorado;

Thence West along the South line of Carbon County and the North line of the State of Colorado to the West line of Township 12 North, Range 86 West;

Thence North along the West line of Townships 12, 13, 14, 15, 16, 17, and 18 North, Range 86 West, to the Northwest corner of Township 18 North, Range 86 West;

Thence East To the Southwest corner of Township 19, Range 85;

Thence North along the West boundary of Township 19, Range 85 to the Northwest corner of Township 19, Range 85;

Thence East along the North line of Township 19, Range 85 to the Southwest corner of Township 20, Range 84;

Thence North along the West boundary of Township 20, Range 84 to the Northwest corner of Township 20, Range 84;

Thence West along the South line of Township 21, Range 84 to the Southwest corner of Township 21, Range 84;

Thence North along the West boundary of Township 21, Range 84 to the Northwest corner of Township 21, Range 84;

Thence East along the North boundary of Township 21, Range 84 to the Northeast corner of Township 21, Range 84;

Thence South along the East boundary of Township 21, Range 84 to the North boundary to Township 20, Range 84;

Thence East along the North boundary of Township 20, Range 84, 83 and 82 to the Northeast corner of Township 20, Range 82;

Thence South along the East line of Townships 20, 19, 18 and 17 North, Range 82 West, to the Southeast corner of Township 17 North, Range 82 West;

Thence East along the North line of Township 16 North, Ranges 81 and 80 West to the Northeast corner of Township 16 North, Range 80 West;

Thence South along the East line of Townships 16, 15, 14, 13, and 12 Range 80 West said line also being a part of the East line of Carbon County, and West of Albany County, to the point of beginning."
