SHERIFF

Don Sherrod & Jerry Colson from the Sheriff's department and Mr. Cook & Mr. Powell from Medicine Bow met with the Commissioners concerning additional law enforcement in the Town of Medicine Bow. Sherrod reported that from the first of the year to date the Sheriff's office has had fifty-two (52) calls. Sherrod said there is a need for a deputy in that area. Estimated costs to put a man in Medicine Bow would be \$32,000.00 for salary and \$20,000.00 for equipment (car, etc.) according to Sherrod.

The Commissioners took no action.

Sherrod and Colson asked for a new jailer to replace Dennis West.

LIBRARY BOARD

Lesley Boughton, Library director, and Candace France, Library board member, met with the Commissioners to discuss cutting library meeting room hours during the evenings: No action was taken by the Commissioners.

ROAD & BRIDGE

Don Neuman, County Road & Bridge supervisor and Richard H. Oates from Wyoming Machinery Company talked about trading some equipment around for the upcoming dust and road maintenance program.

No action was taken by the Commissioners.

Neuman updated the Commissioners on County road maintenance, notified the Board of the resignation of employee John Douglas, and discussed the upcoming Road & Bridge staff meeting.

ROAD & BRIDGE

Neuman told the Commissioners that he would look at the Ryan Park road, and check with the Forest Service. No action was taken by the Commissioners.

HIGH COUNTRY JOINT POWERS BOARD

Cathy MacPherson, representing the High Country Joint Powers Board presented a lease agreement for the Commissioners consideration. The Commissioners want County Civil Attorney Wade Waldrip to read the agreement before signing it.

A motion was made by Wille, seconded by Graalman and carried to enter into the lease agreement with High Country Joint Powers Board following the review of the document by Wade Waldrip, County Civil Attorney.
