CO-OP COMMITTEE

Representatives of the Inter-Departmental Co-op Committee met with the Commissioners to discuss central purchasing. Representatives from McGladry-Pullen reported on the Audit Report. The Commissioners were enlightened.

SARATOGA PLAY & LEARNING

Melody Posey-Harris, of the Saratoga Play & Learning Center said that the center's accounts receivable are not being paid and the center cannot meet payroll. The Center requested \$1,000.00 from the County. Graalman said the Commissioners need to look at the Severance Tax budget before they can give an answer.

U. S. FOREST SERVICE

Mike Murphy of the U. S. Forest Service updated the Commissioners on the Look to the Future forest management program.

FIRE DEPARTMENT

Dwight France of the Carbon County Fire Department, asked approval to attend a fire school being held in Riverton and funding to attend (\$450.00 for the school and \$450.00 for the travel expenses). The Commissioners approved the requests.

PLANNING

Susan Grafton and Cathy Markos met with the Commissioners and requested approval of a resolution supporting a solid waste management education program and recycling project.

A motion was made by Wille, seconded by Graalman and carried to approve the following:

R E S O L U T I O N 1 9 9 0 - 7

RESOLUTION SUPPORTING THE SOLID WASTE MANAGEMENT
EDUCATION PROGRAM AND RECYCLING PROJECT

WHEREAS, Solid Waste Management is recognized as a local
and worldwide concern; and

WHEREAS, the League of Women Voters and the Recycling
Task Force are working to assess the local problem and to
educate and promote community awareness and participation;
and

WHEREAS, cooperation from the citizens, at home and in
the workplace, and from the schools and all government entities
is necessary to reduce the solid waste stream, and to protect
the enviroment and natural resources, through wise purchasing,
reusing and recycling;

NOW, THEREFORE, BE IT RESOLVED BY THE CARBON COUNTY BOARD
OF COMMISSIONERS, that they support the educational efforts of
the League of Women Voters and the Recycling Task Force by pro-
claiming January through December 1991, as

HIGH COUNTRY JOINT POWERS BOARD

RECREATION CENTER ANNEXATION

A motion was made by Wille, seconded by Graalman and carried to approve the annexation of the Recreation Center plat.

LIQUOR LICENSE MORITORIUM

A motion was made by Wille, seconded by Graalman and carried to extend the moritorium on the issuance of new liquor licenses excepting from the moritorium the 24-hour malt beverage permits, for an additional year commencing January 1, 1991 and ending December 31, 1991.

DESIGNATION OF DEPOSITORIES

A motion was made by Wille, seconded by Graalman and carried to approve all F.D.I.C. and F.S.L.I.C. associated Federal and State chartered banks and savings and loans in Carbon County as official depositories.

DESIGNATION OF OFFICIAL PAPER

A motion was made by Wille, seconded by Graalman and carried to appoint Rawlins Newspapers, Inc., specifically the Rawlins Daily Times, as the official paper of Carbon County.

ROAD & BRIDGE

Don Neuman, County Road & Bridge supervisor, updated the Commissioners on buying fuel in Hanna. He thinks this plan will not work for the County.

Neuman talked about a Rail-Highway Warning System project through the Wyoming Highway Department. Neuman has corresponded with George Dale of the Wyoming Highway Department regarding Carbon County participation in the project.

EXECUTIVE SESSION

A motion was made by Wille, seconded by Graalman and carried to enter into executive session.

THERE BEING NO FURTHER BUSINESS, the meeting was adjourned.
