EXTENSION SERIVCE

Marilyn Toellner, Charlene Abbott and Judy Smith, representing the Extension office met with the Board to discuss the possibility of purchasing a new copier and type-writer for that office. The Commissioners approved the purchase of a new type-writer and took the copier purchase under advisement.

SHERIFF

County Sheriff, Don Sherrod updated the Board on the condition of the vehicles used by his department.

Also discussed were the 911 services through the Sheriff's dispatch for other towns in Carbon County and 24-hour dispatch service for the Town of Baggs. The anticipated starting date for the Baggs 24-hour dispatch is February 1st.

DELINQUENT TAX PROPERTIES

A motion was made by Wille, seconded by Graalman and passed to offer at public sale some delinquent tax property.

PUBLIC HEALTH NURSE

Sherrie Patch, Public Health Nurse for Carbon County reported on the Noyes Health Care Center and updated the Board on activities of the Public Health Nurse office. Maureen Ripple, the contract nurse at the Noyes Health Care Center was introduced.

INSURANCE

Bids were received from Allen Insurance and Real Estate, Anthony Agency, Inc. and The Wise Agency all of Rawlins, for an insurance package. The various items covered in the package are: commercial fire, flood, business automobile, commercial general liability, public officials errors & omissions, electronic date processing equipment, radio equipment and sound reproduction systems, contractor's equipment, miscellaneous equipment, camera, photographic equipment, money & securities, boiler & machinery and public employee blanket bond. The bids were taken under advisement.

N.O.W.C.A.P.

Brian Arp and Tyler Paris, representing N.O.W.C.A.P. (Northwest Community Action Programs of Wyoming, Inc.) requested a letter of support from the Board, to be used in applying for Community Service Block Grant discretionary project funds. The grant application is for \$15,392.16 to provide weatherization services to homes in rural areas throughout Carbon County.

A motion was made by Wille, seconded by Graalman and carried to support NOWCAP's application.

CITY OF RAWLINS

Linda Smith and Dave Clark, representing the City of Rawlins, presented the Board with some of the improvement plans for Rawlins. The City of Rawlins requested \$3,000.00 or \$4,000.00 from the County to help implement these plans. Some areas included in the plans are: the Old Pen, the downtown area and the old train depot. The City of Rawlins would also like the County to support efforts in obtaining grant monies for these projects. The requests were taken under advisement.

ROAD & BRIDGE

Don Neuman, County Road Supervisor reported on the Jack Creek Road project being considered by the Town of Saratoga, the traffic count, the bridge in Elk Mountain, fuel tanks, and the need for additional culverts.

The Board approved the ordering of culverts as requested and advised Neuman to contract an engineer for the Elk Mountain bridge project. Also approved was the removal of the fuel tanks at the Medicine Bow shop at a cost of \$1,129.00.

EXECUTIVE SESSION

A motion was made by Wille, seconded by Graalman and carried to enter into executive session. (3:45 p.m.)

FIRE DEPARTMENT

Encampment/Riverside Fire Department, represented by Jeb Steward and Joe Remick reported on a grant from the Farm Loan Board that will build a new fire station for their area at an estimated cost of \$166,000.00. Encampment will contribute 30% of the cost and is requesting the County contribute \$15,000.00 to \$20,000.00. The matter was taken under advisement.

TELEPHONE SYSTEM

Furst Group, represented by Barry Peterson of Casper, Wyoming, presented a savings plan for long distance telephone service. No action was taken.

INSURANCE

A motion was made by Wille, seconded by Graalman and passed to accept the insurance package bid of The Wise Agency at a cost of \$145,615.94.

RAWLINS-CARBON COUNTY AIRPORT BOARD

A motion was made by Wille, seconded by Graalman and carried to appoint Sam Kelly to a five year term on the Rawlins-Carbon County Airport Board beginning February 1, 1990 and ending February 1, 1995.

DIXON AIRPORT BOARD

A motion was made by Wille, seconded by Graalman and carried to appoint Ray Weber and Robert Golden to five year terms on the Dixon Airport Board.

A motion was made by Wille, seconded by Graalman and carried to appoint Jerry Wilson and Harry Russell III to five year terms on the Dixon Airport Board.

THERE BEING NO FURTHER BUSINESS, the meeting was adjourned. (6:45 p.m.)
