PLANNING

The administrator's report for the month of February, 1990 was presented by Susan Grafton.

ECONOMIC DEVELOPMENT

Mike Hickman, representing the Economic Development Corp. reported on the Green Mountain ski project and the new penitentiary proposal.

Jeff Thorpe, also representing the Economic Development Corp. reported on his trip to California to meet with prospective developers of foundries in the Rawlins area. He requested funding for more travel to pursue foundry development.

FIPE DEPARTMENT

The County Fire Department requested \$11,155.00 to purchase a U. S. surplus 6x6 truck. The Board approved \$5,000.00 to purchase a 6x6 truck from the Fire Department new equipment budget.

ROAD & BRIDGE

County Road Supervisor, Don Neuman reported on the following topics: Allen Mace's remarks and recommendations resulting from his work on County roads; a letter from the U. S. Army Corps of Engineers on County Road #401; the safety area extension of County Road #385 in the Saratoga area; and the use of a Road & Bridge vehicle by the Museum Board to attend a meeting in Colorado.
