County Radio Technician, Clayton Kilgore requested the purchase of radio equipment at a cost of \$7,000.00. The Commissioners approved the purchase.

C.O.V.E.

Jana Hejke, representing C.O.V.E. updated the Commissioners on their monument project.

PARK MANOR

Buddy Rae, of Park Manor discussed a county land transfer. The Commissioners will run an advertisement in the newspaper for public input regarding the transfer.

PLANNING

Robert Konrath and Nina Adams representing the Planning Commission, discussed an addressing system. Adams reported on a proposal for a county zoning project prepared by William J. Gribb.
