A resolution by the Commissioners of Carbon County, Wyoming to develop a land use plan for Carbon County.

June 2, 1992

WHEREAS Wyoming Statutes 18-5-101 through 18-5-315 provide counties in Wyoming the authority to develop and implement Land Use Plans; and

WHEREAS the Carbon County Commissioners desire to develop and implement a Land Use Plan which will facilitate and protect the natural resource base, private property interest, and the tax base of Carbon County; conserve and protect the historical customs and culture unique to Carbon County and the State of Wyoming.

NOW THEREFORE be it resolved the Carbon County Commissioners hereby request the Carbon County Coalition, in cooperation with the Carbon County Planning Commission, to develop and submit a Land Use Plan for Carbon County Commissioner's approval.
