## RATTLESNAKE PASS ROAD

Carolyn Duncan met with the Commissioners to inquire about application for farm to market funds to do work on the Rattlesnake Pass Road. Zeiger explained that Carbon County's farm to market money is spoken for to be used on the Seminole road and rural bus routes.

Duncan requested permission to pursue grants available to improve the road. Zeiger and Graalman agreed to the proposal providing the County wouldn't be obligated monetarily.

Don Neuman, County Road & Bridge Supervisor, requested an executive session to discuss personnel.


## ROAD &amp; BRIDGE
