TOWN OF BAGGS

PUBLIC HEALTH

Neuman discussed starting a SC-CFM project in conjunction with the Wyoming Department of Transportation to remove 24,000 tons of material from I-80. The material would cover approximately twelve miles of road.

A motion was made by Fleming, seconded by Graalman and unanimously carried to come out of executive session. (4:00 p.m.)


AMOCO
