U.S. 287 HIGHWAY

A motion was made by Fleming, seconded by Graalman and unanimously carried to approve the following:

R E S O L U T I O N 1 9 9 3 - 1 5

A RESOLUTION OF THE CARBON COUNTY COMMISSIONERS,
WYOMING, REQUESTING THE STATE OF WYOMING TO
DEVELOP AND CONSTRUCT SAFETY IMPROVEMENTS TO
HIGHWAY 287-220

WHEREAS, U. S. 287 and State Highway 220 serves the major
transportation link between Carbon County, Natrona County and
Fremont County; and

WHEREAS use of this two lane highway has increased sub-
stantially in recent years, particularly by large cross country
trucks; and

WHEREAS, this highway has been the scene of seven traffic
deaths in a recent twenty-two (22) day period and thirteen (13)
deaths in the past ten months; and

WHEREAS, there is clearly an urgent need to make safety
improvements to this highway to accommodate its increased traffic
and to prevent further loss of life; and

NOW, THEREFORE, BE IT RESOLVED by the Carbon County Commis-
sioners, the Governing Body of Carbon County, Wyoming, that the
State of Wyoming Department of Transportation reevaluate the
safety of and take whatever steps are necessary to improve the
safety of Highway 287-220 to prevent further loss of human life.

Home.

Carbon County Public Health Nursing Service and Jim Zimmerman, Physicians Assistant.

A.D.A.

Irene Archibald to bring Carbon County into compliance according to A.D.A. standards.

ROAD & BRIDGE

County Road & Bridge Supervisor, Don Neuman gave his administrator's report.

UPPER PLATTE RIVER SOLID WASTE DISPOSAL DISTRICT BOARD

A motion was made by Fleming, seconded by Graalman and unanimously carried to appoint
Doug Youngberg to a three year term on the Upper Platte River Solid Waste Disposal
District Board beginning September 4, 1993 and ending September 4, 1996. This ap-
pointment replaced Larry Bockman.

William M. Lamos to a three year term on the Upper Platte River Solid Waste Disposal
District Board beginning September 4, 1993 and ending September 3, 1996.

The Commissioners signed an agreement for a right of way easement with John Neal Nixon and Margaret M. Nixon for County Road 501.


The Commissioners signed an agreement for fence ownership with Blake Sheep Company in the right of way of County Road 340.
