LAND ACCESS


Janice Ward met with the board concerning access to her property at Savery.

County Road & Bridge Supervisor, Don Neuman gave his administrator's report.


The Commissioners signed a grant draft request for \$107,893.95 for SC-CFM 6-40 Sage Creek & Jack Creek road improvements.
